
- Implementation for 2016-17
 - Funding formula presented to the State Board of Education for action on August 10
 - Vendor list includes recommendations collected from schools and corporations last spring
 - Program implementation improved
 - Use pupil enrollment counts from 2015-16
 - Aligns with other grants
 - Improves timeline for distribution of dollars
 - Local contracts only (no "savings" for state contract)
 - Avoids confusion regarding billing for corporations
 - Expedites vendor program services





- ISTAR test design based on TAC recommendations
 - Utilize design option 3 for at least a year to establish stable item statistics
 - Placement test combined with Part 1
 - Informs placement into access level for Part 2
 - Implement two test windows in 2016-17
 - Part 1 during existing January window
 - Part 2 during existing April window







- Sharing 2015-16 results with students, parents, and schools
 - Tier assignment; percent of items correct
 - Questar currently creating draft report documents
 - Disseminate early fall





- ISTEP+ Spring 2016 results
 - Updated reporting timelines
 - Grades 3-8
 - Grade 10



- Standard setting (cut score setting) for ISTEP+ Grade 10 ELA, Math, and Science
 - August 2-3, 2016
 - Recommended cut scores presented to the State Board of Education for action on August 10



- Online and paper/pencil mode adjustment recommendations
 - Grades 3-8 and 10
 - Presentation to the State Board of Education for action on August 10
