RESOLUTION TO AMEND THE PERU COMMUNITY SCHOOL CORPORATION REORGANIZATION PLAN TO COMPLY WITH HEA 1074 REGARDING ELECTION DATES FOR SCHOOL BOARD MEMBERS

RESOLVED, that due to a change in the state law pursuant to HEA 1074 requiring that beginning in 2012 school board members selected by election must be elected at general elections and take office the following January, 1, the Peru Community School Corporation Reorganization Plan is now amended, effective with the general election to be held November, 2012, as follows:

- 1. Successors to the two (2) current Trustees elected from Peru Townships 2-9 and Washington 1 within the city limits and annex districts at the 2008 primary election:
 - 1.1. shall be elected at the 2012 general election,
 - 1.2. shall take office on January 1, 2013, and
 - 1.3. all terms of office shall be for four years.
- 2. Successors to the two (2) current Trustees elected from Peru Townships 2-9 and Washington 1 within the city limits and annex districts at the 2010 primary election:
 - 2.1. shall be elected at the 2014 general election,
 - 2.2. shall take office on January 1, 2015, and
 - 2.3. all terms of office shall be for four years.
- 3. Successors to the two (2) current Trustees elected from Erie Township and Peru Townships 10 & 11 who were elected at the 2008 general election:
 - 3.1. shall be elected at the 2012 general election,
 - 3.2. shall take office July 1, 2013, and
 - 3.3. shall serve a one-time three and one-half (3½) year term through December 31, 2016, with each term thereafter being for four (4) years, starting January 1, 2017.
- 4. Successor to the one (1) current Trustee elected from Peru Townships 2-9 and Washington 1 within the city limits and annex districts at the 2010 general election:
 - 4.1. shall be elected at the 2014 general election
 - 4.2. shall take office July 1, 2015
 - 4.3. shall serve a one-time three and one-half (3½) year term through December 31, 2018, with each term thereafter being for four (4) years, starting January 1, 2019.
- 5. All of the provisions of the original plan of reorganization shall remain in full force and effect except to the extent modified herein.
