



## MEMORANDUM

**TO:** State Board of Education

**SUBJECT:** Remediation and Preventive Remediation Distribution

**DATE:** April 4, 2012

[Indiana Code 20-32-8-5](#) provides that the State Board of Education and the State Budget Agency shall approve, and the State Budget Committee shall review, the ISTEP+ Remediation and Preventive Remediation Grant formula.

The law requires that remediation funds be allocated among school corporations and charter schools on the basis of the percentage of students who do not achieve a passing score on ISTEP+. Students whose ISTEP+ scores are farthest below the passing score have generated the largest per pupil per subject amount. The proposed distribution formula for English/language arts, mathematics, science and social studies includes three tiers. Students who score at or above the passing score do not generate funds.

We request approval of one distribution in calendar year 2012. The distribution will be made this spring and, given full participation by school corporations and charter schools, will total \$3,000,076.48. Per pupil funding at Tier 1 is \$15.50, at Tier 2 is \$7.70 and at Tier 3 is \$3.84. The distribution is based on the spring 2011, administration of ISTEP+.
