ALCOHOL AND TOBACCO COMMISSION

MAY 21, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, General Counsel Merritt, and Deputy Director Serak were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the May 8, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Seventy-five dispositions were submitted with fines totaling \$46,700.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

RR45-20186 SHADES OF TIME, INC. – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated there were remonstrators from the police department who submitted exhibits regarding police runs and problems at the establishment.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

RR46-01558 BLACKHAWK INN, INC. – Chair Allen noted this is a new application with the local board voting 3-0 to deny with one abstention.

Commissioner Maginn stated this business has had violations for serving minors and serving an intoxicated individual. They were placed on PACE, but still received additional violations.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal.

Vice Chairman Payne asked if it was necessary to formally remove the business from PACE.

Commissioner Maginn amended the motion to include removing the business from PACE. Commissioner Jones seconded. The motion was unanimously approved.

RR68-40993 WILLOW'S EDGE LLC – Chair Allen noted this is a request for the permittee to be designated as a catering hall.

Commissioner Maginn moved to approve the request. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-40803 ROI TACO LLC – Chair Allen noted this is a new application with the local board voting 4-0 to deny.

Commissioner Maginn stated the applicant appeared at the first local board hearing, but there were issues that needed correcting. After the first meeting, the applicant never returned to appear before the board.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

RR49-40539 THE BOTANICAL BAR LLC – Chair Allen noted this is a new application with the local board voting 4-0 to deny.

Commissioner Maginn stated the applicant appeared at the first local board hearing, but there were issues that needed correcting. After the first meeting, the applicant never returned to appear before the board.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

RR27-31333 JUICETV LLC – Chair Allen noted this permit was denied escrow. The renewal is before the Commission for their recommendation.

Commissioner Maginn moved to deny the renewal, due to the permittee not appearing for escrow hearings, which resulted in denial of escrow. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-18293 MARIA MONSERRAT AVALOS HERNANDEZ LLC– Chair Allen noted this is a Motion to Reconsider the Remand. The Commission remanded the renewal to the local board after observations were brought to light regarding the food sales' requirements possibly not being met.

Commissioner Maginn noted the establishment has had violations in the past. She also stated that the local board requested remand for the purpose of investigating the food sales' figures.

Chair Allen mentioned that the permittee is possibly going to apply for a different permit that would not be affected by food sales.

Commissioner Maginn moved to deny the request to reconsider the remand. Commissioner Jones seconded. The motion was unanimously approved.

RR49-37477 SILVER BULLET BEECH GROVE LLC – Chair Allen stated this is a Motion to Reconsider the issuance of an extension. The request is based on the fact that the transferee is operating the business, not the current owner, who was denied renewal.

Commissioner Maginn wants to give the new operators a chance to see how they manage while the transfer is pending, so she moved to approve a 3rd extension. Vice Chairman Payne seconded.

Chair Allen noted that the former mayor remonstrated against the renewal and the police department appeared at the local board hearing, not necessarily to remonstrate, but to make their presence known.

Chair Allen voted to approve.

Commissioner Jones reluctantly voted to approve, with the understanding that new managers are operating and need to make sure rules are followed.

The motion passed unanimously.

RR49-31978 MUG O INC. – Chair Allen noted this is a request for an extension.

Commissioner Maginn stated this is the 3rd request for extension, the reason being the death of an owner and the need to file paperwork.

Commissioner Maginn moved to approve the extension. Commissioner Jones seconded. The motion was unanimously approved.

DL45-16057 L & RS, INC. – Chair Allen noted this is a request for an extension. An investigatory hearing was held to find out why ownership was not transferred 10 years ago. The permittee thought their counsel was handling the situation but did not. The permittee is now trying to work through the process of making the corrections.

Chair Allen moved to approve the extension. Commissioner Maginn seconded. The motion was unanimously approved.

RR49-33276 KINFOLKS EVENT CENTER – Chair Allen stated this is a request for reconsideration of approval for an extension. An extension was granted inadvertently with a pending violation. The error was caught when the permittee did not appear for a prehearing regarding the violation. The Chair noted the extension was rescinded at the last meeting. The violations are now settled.

Commissioner Maginn moved to reinstate the extension. Vice Chairman Payne seconded. Chair Allen voted to approve. Commissioner Jones voted to deny. The vote was 3-1 to approve reinstatement of the extension.

RR49-18714 P.F. CHANG'S CHINA BISTRO, INC. – Chair Allen noted this is a request for extension.

Commissioner Maginn stated this is a 4th extension request. The permittee is working through ownership disclosure issues.

Commissioner Maginn moved to approve the 4th extension request. Commissioner Jones seconded. The motion was unanimously approved.

RR02-34452 P.F. CHANG'S CHINA BISTRO, INC. – Chair Allen noted this was a request for extension.

Commissioner Maginn stated this is a 3rd extension request. The permittee is working through ownership disclosure issues.

Commissioner Maginn moved to approve the 3rd extension request. Commissioner Jones seconded. The motion was unanimously approved.

RR71-02950 KELLY-ROSS CORP. – Chair Allen noted this is a request for extension that was sent to the Commission at the end of business yesterday.

Commissioner Maginn stated there was not adequate time to review the record, so she moved to continue this to the May 29th escrow hearing date. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-34949 BEMBAR, INC. – Chair Allen noted this is a request for extension. This permit was on the last meeting agenda. It was removed because we thought it was a first extension request, however, it was a 2nd request.

Chair Allen moved to approve the 2nd extension request. Commissioner Maginn seconded. The motion was unanimously approved.


ADJOURNMENT

Commissioner Jones moved to adjourn the meeting. Vice Chairman Payne seconded. The motion was unanimously approved.



Noteworthy Violations for 5/21/24 Commission Meeting

RR1403710: Rapar, Inc. (DBA: Angle Inn) in Washington, Daviess County. On February 25, 2024, there was a stabbing incident at the business and District 5 Officer Joshua Clifford began an investigation. Off. Clifford contacted the assigned Washington Police Department detective, reviewed video surveillance of the incident, and reviewed call logs from the business for the past 2 years. It was determined the victim was stabbed multiple times in the parking lot, after a fight began inside the business. Violations were written for public nuisance and failure to remove containers after closing hours. **The parties have agreed to a \$1,500 civil penalty and a 3-day weekend suspension of the alcohol permit. As an additional note, the business will be closing in June 2024.**

RR4937171: Pilot Pursuit LLP (DBA: Recovery Room Lounge) in Indianapolis, Marion County. On December 24, 2023, the Marion County Task Force was notified of a woman being shot in the head at the business. A few days later, the Task Force met with the owner and conducted a permit visit. It was determined a promoter was in charge of the premise on the night of the shooting. Numerous violations were written for public nuisance, disclosure of interested parties, falsification of records, service of setups, etc. **The parties have agreed to a \$2,000 civil penalty and in lieu of revocation of the alcohol permit, the business shall remain closed and agrees to transfer the permit to an unrelated party at a different location.**

RR4933276: Kinfolks Event Center LLC (DBA: Illusions Bar & Grill) in Indianapolis, Marion County. In September 2023, Officer Swallow received a complaint from the Pike Township Fire Department regarding a "Wagon Wednesday" promotion at the business. It was determined a problem promoter was in charge of the premise on Wednesday evenings. On September 27, 2023, a search warrant was executed at the business. Officers found numerous issues during the visit and violations were written for public nuisance, dealing in unauthorized beverages, nudity, refilling bottles, etc. **The parties have agreed to a \$2,500 civil penalty and a 3-day weekend suspension of the alcohol permit.**
