MINUTES

ALCOHOL AND TOBACCO COMMISSION

MAY 8, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, General Counsel Merritt, and Deputy Director Serak were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the April 16, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Ninety-two dispositions were submitted with fines totaling \$71,800.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

<u>TC13447001 MUNDEN LLC</u> – Commissioner Jones, who sat as hearing judge in this matter, stated this certificate holder was cited for selling tobacco to a minor and sent a settlement offer from the prosecutor. This was the third violation of selling to a minor. The certificate holder requested a hearing on the matter. A hearing was held, exhibits were presented, and testimony was heard. The proposed Findings of Fact and Conclusions of Law were submitted for consideration.

Commissioner Jones found the violations were true and recommended a \$1,000.00 fine and a three-day suspension as penalty. Vice Chairman Payne seconded. The motion was unanimously approved.

CONSIDERATION OF APPLICATIONS

Chair Allen asked the Commission to add by consent any new permits that may have been added to the lists of approvals after posting the agenda. Consent granted.

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move

for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Vice Chairman Payne seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

<u>RR71-36368 THE SOCIAL LLC</u> – Chair Allen noted this is a renewal with the local board voting 2-1 to approve for 1-year.

Commissioner Maginn stated this permittee has had several violations, some dealing with minors. The owners have added new staff and new measures to help alleviate the problems.

Commissioner Maginn moved to uphold the local board's recommendation to approve for one-year. Vice Chairman Payne seconded.

Commissioner Jones stated he reluctantly supports the motion due to the nature and number of violations linked to this establishment. He hopes the owner pays closer attention.

The motion was unanimously approved.

<u>RR45-40950 KEYNA RODGERS</u> – Chair Allen noted this is a new application with the local board voting 3-1 to approve.

Commissioner Maginn stated there was discussion at the local board about improper zoning, which is not something the Commission controls. The applicant wants to get approval for the permit before dealing with zoning. The Commissioner made a point to say the business plans to only allow patrons over the age of 25.

Commissioner Maginn moved to uphold the local board's recommendation to approve. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR12-35672 FIRE & ICE FOODS, LLC</u> – Chair Allen noted this is a request for the permittee to be designated as a catering hall.

Commissioner Maginn moved to approve the request. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-32573 SREE PROPERTIES LLC</u> – Chair Allen noted this is a request to file a transfer application.

Commissioner Maginn stated the renewal was denied and an appeal was filed. Now the permittee has requested the ability to drop the appeal and to be allowed to file a transfer.

Commissioner Maginn moved to allow the transfer of the permit. Commissioner Jones seconded.

Chair Allen asked for a clarification of the motion only allowing the filing of the transfer paperwork and not allowing the transfer.

Commissioner Maginn amended the motion. Vice Chairman Payne seconded. The motion was unanimously approved.

RR84-01881 GREG A WILSON – Chair Allen noted this is a request for remand of the renewal.

Vice Chairman Payne stated the permittee appeared before the local board not prepared to discuss a violation and appeared to be somewhat confused. The renewal was denied, and an appeal was filed. The permittee has obtained an attorney who has submitted a request for remand of the renewal to provide information and an explanation to the local board regarding the violation.

Vice Chairman Payne moved to approve the request. Commissioner Maginn seconded.

Commissioner Jones stated he is voting against the motion based on what transpired at the local board hearing and that it was a 4-0 vote to deny.

The motion was approved 3-0 with 1 vote against.

<u>RR49-37477 SILVER BULLET BEECH GROVE LLC</u> – Chair Allen noted this is a request to allow the filing of a transfer and approval of an additional extension.

Commissioner Maginn stated the renewal was denied and an appeal was filed. Now the permittee has requested the ability to drop the appeal and file a transfer application. The establishment has had several problems including numerous police runs and two shootings.

Commissioner Maginn moved to allow the filing of a transfer. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Maginn moved to deny the request for a third extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-33276 KINFOLKS EVENT CENTER LLC</u> – Chair Allen noted this is a request for extension with a pending violation.

Commissioner Maginn stated the violation has to do with promoters operating the business. A corrective action plan was submitted stating there would be no promoters and addressed additional problems.

Commissioner Maginn moved to approve the first extension. Vice Chairman Payne seconded.

Chair Allen made note that counsel has been obtained and a prehearing conference was scheduled, but no one appeared on behalf of the permittee. The corrective action plan addresses problems, but the current practices appear to not follow that plan.

Commissioner Jones agreed with the Chair and her assessment of the situation.

Commissioner Jones and Chair Allen voted against approval of the extension making the vote 2-2, with the Chair being the deciding vote. The request was denied.

<u>RR79-34150 CAPITAL CONNECTION</u> – Chair Allen stated this permittee was previously placed on PACE. However, the location of the business has been demolished and the permit is in escrow.

Commissioner Maginn moved to remove the permittee from PACE. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-09422 SKYLINE CLUB LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn moved to approve the extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR76-36424 ROLLING VALLEY FARMS LLC</u> — Chair Allen noted this was a request for a first extension with a violation. The violation has been settled, so this item was removed from the agenda.

<u>RR49-34949 BEMBARS INC.</u> – Chair Allen noted this was a request for a first extension with a violation. The violation has been settled, so this item was removed from the agenda.

RR71-38702 WESTERN LLC – Chair Allen noted this is a request for extension.

Commissioner Maginn stated this is a second request for extension. There is a problem with the Secretary of State's paperwork.

Commissioner Maginn moved to approve one final extension to allow time to fix this problem. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL18-31433 BCD INC</u> – Chair Allen noted this was a request for a first extension with a violation. The violation has been settled, so this item was removed from the agenda.

RR88-16023 THE ORIGINAL POP-A-TOP INC. – Chair Allen noted this is a request for extension.

Commissioner Maginn stated there are problems with the permittee's sewer and payment of property taxes.

Commissioner Maginn moved to allow one final extension to give time to correct these issues. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR02-33630 BILL'S BISTRO LLC</u> – Chair Allen noted this was a request for a first extension with a violation. The violation has been settled, so this item was removed from the agenda.

<u>RC61-89315 AMVETS PARKE COUNTY POST #61 INC.</u> – Chair Allen noted this is a request for extension.

Commissioner Maginn stated they are updating officers and managers.

Commissioner Maginn moved to approve the extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-06959 H.A.T ENTERPRISES INC.</u> – Chair Allen noted this permittee is currently operating on an extension. She requested this be added to the agenda by consent. Consent was granted.

Commissioner Maginn stated there have been several shootings at this establishment in a period of just a few days.

Commissioner Maginn moved to revoke the extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR46-01558 BLACKHAWK INN, INC.</u> – Chair Allen noted this is a request for extension. She requested this be added to the agenda by consent. Consent was granted.

Commissioner Maginn stated the local board recommended denial of the renewal. The renewal does not come before the Commission until the May 21st meeting. There have been several violations with one settlement offer being for revocation of the permit.

Commissioner Maginn moved to deny the issuance of the extension. Commissioner Jones seconded. The motion was unanimously approved.

Noteworthy Violations for 5/8/24 Commission Meeting

RR7103567: Linn Corporation (DBA: Frank's Place) in South Bend, St. Joseph County. On three separate days, 9/27/23, 10/30/23, and 2/6/24, District 1 Officer Javier Arroyo checked on the business to make sure they were operating within the terms of their permit. Each time, the package store side of the business was open, however the restaurant side was not. Off. Arroyo cited the business on all three occasions. With the help of local board officer Michelle Traughber, we were able to confirm the permittee knew the rules and regulations when he took over the permit. The parties have agreed to a combined \$3,000 civil penalty and an 8-day suspension of the alcohol permit.

RR4935771: El Fandangos, Inc. (DBA: El Fandango's Night Club) in Indianapolis, Marion County. On February 2, 2024, following a complaint from IMPD, Marion County Task Force Officers Alan Wombolt and Adam Buckley conducted an investigation at the business. They discovered numerous violations, including falsification of records, after hours sales, retail to retail sales, juveniles in the business, and minimum food requirements. Additionally, evidence was uncovered that the business' parking lot had been the site of two recent shootings. The parties have agreed to a \$3,000 civil penalty and a 3-day weekend suspension of the alcohol permit.

<u>TC15181001</u>: Vape Paradise Inc. (DBA: Smoke Kingdom) in Indianapolis, Marion County. On March 5, 2024, District 6 Excise Officers Matthew Snyder and Haley Cox conducted a permit visit at the business. During the visit, they observed staff sell tobacco products to a 19-year-old subject. Violations were written for sale of tobacco to a minor and allowing a minor in a tobacco store. This is the 3rd violation for sale to a minor in less than two years. **The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the tobacco certificate.**

- 2. This matter is set for pretrial on the request of the Permittee's request for ATC to hear the appeal of the Marion County Local Board's decision denying the renewal of this Permittee's permit.
- Counsel advised that the Permittee is transferring this license at an arm's-length transaction and the matter will be scheduled for the local board hearing in early May 2024.
- 4. Counsel requests that this matter be rescheduled for an administrative, virtual hearing for potential withdrawal of the Petition to Review the denial of the renewal of the permit in this matter.
- 5. The Hearing Judge sets this matter for June 13, 2024, 11:00 AM.
