MINUTES

ALCOHOL AND TOBACCO COMMISSION

JUNE 18, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Prosecutor Wignall, General Counsel Merritt, and Deputy Director Serak were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the June 4, 2024 meeting. Commissioner Maginn seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> — Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Seventy-eight dispositions were submitted with fines totaling \$53,100.00. Commissioner Maginn seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Vice Chairman Payne moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Vice Chairman Payne moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Vice Chairman Payne moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Vice Chairman Payne moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Vice Chairman Payne moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Commissioner Maginn moved to approve the fee waived letters of extension issued the preceding weeks. Vice Chairman Payne seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

<u>RR49-40670 P & R ENTERTAINMENT LLC</u> – Chair Allen noted this is a transfer with the local board voting 4-0 to deny.

Commissioner Maginn stated the seller of the permit has withdrawn their consent to transfer. The buyer was told if the transfer application was not withdrawn and it was denied, there would be no ability to apply for a permit for a year. The transfer application was not withdrawn.

Commissioner Maginn moved to uphold the local board's recommendation to deny the transfer. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-37171 PILOT PURSUIT LLP</u> – Chair Allen noted this is a renewal with the local board voting 3-1 to deny.

Commissioner Maginn stated there were problems at this establishment including a shooting, marijuana use, no employee permits. The owner closed the business pursuant to a violation settlement with the prosecutor. The owner has stated that she is in over her head.

Vice Chairman Payne moved to uphold the local board's recommendation to deny the renewal and allow the filing of a transfer. Chair Allen seconded. Commissioner Maginn voted no to the motion. The motion passed 2-1.

Chair Allen referenced the ATC rule on transfer of denied permits and it states the Commission may place the denied permit in escrow and allow a reasonable amount of time for the applicant to sell. The permit will have to remain in denied status.

<u>RR49-18293 MARIA MONSERRAT AVALOS HERNANDEZ</u> — Chair Allen noted this is a renewal with the local board voting 4-0 to deny. The local board previously voted to approve the renewal, but asked for a remand due to qualification issues regarding the type 209 permit not meeting the food sales requirement.

Commissioner Maginn stated the food figures on the current application appeared to be cut and pasted from the previous year. Excise also noted the kitchen did not appear to be operational or have minimum food available, but a food truck was outside the business. The permittee would like to swap the type 209 permit for a type 210 permit, where there would not be a food sale amount required.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal and allow 45 days for the filing of a transfer to a 210. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-28549 SUITE 38 INC.</u> – Chair Allen noted this is a renewal with the local board voting 2-1 to deny, with 1 abstention.

Commissioner Maginn stated the business has a history and reputation of minors loitering and being served at the establishment. She also made note there is a pending violation.

Chair Allen made reference to the owner saying that having only a few minors in the establishment when 400 to 600 people were inside were "good odds". The Chair said if the business could not police minors, maybe 400-600 people should not be allowed at one time.

Vice Chairman Payne stated the owners closed the establishment after the last incident which was an assault involving a minor.

Vice Chairman Payne moved to uphold the local board's recommendation to deny the renewal, allow 45 days to file a transfer and to work with the prosecutor to resolve the pending violation. Chair Allen seconded. Commissioner Maginn voted no. The motion was approved 2-1.

<u>DL49-32456 VP51, INC.</u> – Chair Allen noted this is a renewal with the local board voting 4-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR02-41141 THE THRONE LLC</u> – Chair Allen noted this is a new application with the local board voting 4-0 to deny.

Commissioner Maginn stated the business has been operating without being approved for a permit. They applied for a temporary event permit that was denied, but chose to operate. Ownership is in question. Marijuana, Ecstasy, unregistered guns, and alcohol purchased from a retailer were found at the location.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Vice Chairman Payne seconded. The motion was unanimously approved.

Chair Allen noted the applicant denied liquor being present even though it was found. Excise was served during investigation. The applicant also said he would not check his employees for drugs at work and one was seen actively smoking on the patio and sharing with others.

<u>RR45-40949 MARCELL JACKSON</u> – Chair Allen noted this is a new application with the local board voting 4-0 to deny for failure to appear.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Vice Chairman Payne seconded. The motion was unanimously approved.

RR82-41323 1313 NEWTON HOLDINGS LLC – Chair Allen noted this is a transfer with the local board voting 2-1 to deny with 1 abstention.

Commissioner Maginn stated the applicant owns numerous other adult establishments, one in Indianapolis was shut down due to several problems. He falsely testified before the local board that it was not.

Chair Allen stated the applicant told the local board that Mr. Carlson was ½ owner of the Indianapolis permit that was denied, but he was never listed on the application.

Commissioner Maginn moved to overturn the local board's recommendation and deny the transfer. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR55-35386 THE BRICKHOUSE AND LOFT LLC</u> - Chair Allen noted the owner is requesting a catering hall designation.

Commissioner Maginn moved to approve the request to be designated as a catering hall. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR18-11489 CHERYL EGAN, INC.</u> – Chair Allen noted this permit was denied escrow for failure to appear for escrow hearings. The renewal is now before the Commission.

Commissioner Maginn moved to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR39-00970 HISTORIC MADISON INN ON BROADWAY INC.</u> - Chair Allen noted this permit was denied escrow for failure to appear for escrow hearings. The renewal is now before the Commission.

Commissioner Maginn moved to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-37768 THUNDERBIRD PROPERTIES LLC</u> – Chair Allen noted this is a request to reverse pending auction status.

Vice Chairman Payne stated the permittee has a buyer. The negotiations were ongoing prior to being placed in pending auction status.

Vice Chairman Payne moved to reverse the status back to active. Commissioner Maginn seconded. The motion was unanimously approved.

Chair Allen stated there was an accusation made by the permittee's counsel that the language of the expired letter is ambiguous. The Chair noted the language states "The permit expired on November 8, 2023." And the very next sentence says, "It will revert to the Alcohol and Tobacco Commission if it is not renewed within 6 months of expiration." The letter clearly states, 6 months from expiration, not the date of the letter. However, there may have been confusion by the permittee believing some paperwork had been submitted but had not.

RR27-31333 JUICETV, LLC - Chair Allen noted this is a request to reverse denial due to denial of escrow.

Commissioner Maginn stated escrow hearing notices were sent and the notice of denied escrow and possible denial of the renewal with no response from the owner. The Commission denied the renewal and notice was sent. The owner left a voicemail recently stating the permit was sold two years ago and she is no longer responsible for it. No paperwork has been submitted for any kind of transfer.

Chair Allen noted the notices ordering the permittee to appear were sent and instead of checking with the Commission, the notices were ignored, and no one appeared.

Commissioner Maginn moved to uphold the denial of the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-36274 NITE OWLS LLC</u> – Chair Allen noted this is an extension request that was continued from the last meeting to sort out whether the violations have been settled. The signed Settlement Agreement and fine payment were brought into the office this morning.

Commissioner Maginn stated the violations were extensive. A corrective action plan was submitted, and the business will be placed on PACE.

Commissioner Maginn moved to approve the request for extension. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-18929 P.F. CHANG'S CHINA BISTRO, INC. - Chair Allen noted this is a request for extension.

Commissioner Maginn stated the permittee is dealing with ownership issues.

Commissioner Maginn moved to approve the extension request. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-35258 AND RR49-34258 CONDADO TACOS</u> - Chair Allen noted the permittee is requesting extensions for both permits.

Commissioner Maginn stated the permittee is dealing with ownership issues.

Commissioner Maginn moved to approve the extension requests. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-03006 DEER-BELL, INC. – Chair Allen noted this is a request for extension.

Commission Maginn stated the business has two violations and a tax protest that needs to be cleared. A corrective action plan was submitted.

Commissioner Maginn moved to approve the extension request when the tax protest is clear. Vice Chairman Payne seconded. The motion was unanimously approved.

Vice Chairman Payne moved to make 14 permits dead. Commissioner Maginn seconded. The motion was unanimously approved.

Noteworthy Violations for 6/18/24 Commission Meeting

RR2030343: Dessy Corporation (DBA: Phyls Corner) in Elkhart, Elkhart County. In February 2024, District 1 received a complaint from the Elkhart Police Department about violence at the business, including a recent shooting. Officers Kaycee Sullivan and now Sgt. Joe Formato were assigned to investigate. They pulled service runs and reports for the past year and discussed the ongoing problems Elkhart PD detectives. There were several reports involving violence and the business had nearly three times as many calls for service as any other bar in the area. A violation was written for public nuisance and failure to maintain a high and fine reputation. The parties have agreed to a \$1,500 civil penalty and a 3-day weekend suspension of the alcohol permit.

RR4903006: Deer-Bell Inc. (DBA: Club Rio) in Indianapolis, Marion County. In the summer of 2023, the Marion County Task Force received multiple complaints of prostitution at the business. Two separate investigations were conducted and two violation notices were written to include: public nuisance, nudity, falsification of records, sale to intoxicated persons, no manager's questionnaire, hinderance, no employee permits, etc. Of note, there were ties to a former adult entertainment business in Montgomery County that closed for similar issues involving prostitution. The parties resolved both violations for a combined \$4,500 civil penalty and a 5-day suspension of the alcohol permit.
