MINUTES

ALCOHOL AND TOBACCO COMMISSION

JULY 2, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, General Counsel Merritt, and Deputy Director Serak were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the June 18, 2024 meeting. Commissioner Maginn seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Forty-five dispositions were submitted with fines totaling \$27,950.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

<u>BR1889257 TERRANCE WRAY</u> – Commissioner Maginn stated this applicant was denied an employee permit because he is not eligible to hold the permit due to having two OWI convictions. An appeal was filed and a hearing was held. The applicant did not appear at the hearing.

Commissioner Maginn moved to uphold the denial. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR45-34044 SAINT JOHN MALT BROTHERS INC.</u> – Vice Chairman Payne, who sat as hearing judge in this matter, stated this permittee failed to appear for a settlement conference with the prosecutor regarding violations. The matter was set for an Order to Show Cause hearing and no one appeared. The Vice Chairman now submits the Order on Show Cause for recommendation to the Commission.

Vice Chairman Payne moved to revoke the permit. Commissioner Jones seconded. The motion was unanimously approved.

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine seller applications. Commissioner Maginn seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Maginn seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

<u>RR76-41243 BYRNE MARINE, INC.</u> – Chair Allen noted this is a new application with the local board voting 3-1 to approve.

Commissioner Maginn stated this applicant filed for a permit and proceeded to sell alcoholic beverages prior to the permit being approved. They also had been denied a temporary permit.

Commissioner Maginn moved to approve the permit for one year because the local board recommended 3-1 to approve, but stated she may not look favorably on renewing the permit if there are any problems at the establishment. Vice Chairman Payne seconded.

Chair Allen stated she hopes that if the permit is granted, they follow all rules and regulations that go along with holding an alcoholic beverage permit.

Commissioner Jones stated he cannot support the permit because they failed to follow the rules and regulations of the State.

Chair Allen called for a vote. Commissioner Maginn and Chair Allen vote to approve for one year. Vice Chairman Payne and Commissioner Jones voted no. The motion passed.

<u>DL72-33726 WAL-MART STORES EAST LP</u> – Chair Allen noted this is a new application with the local board voting 3-0 to deny.

Commissioner Maginn stated there were remonstrators present. Scottsburg has a long history of not wanting alcohol sold in grocery stores. They have no problem with restaurants and package stores with

alcohol permits, so there are plenty of establishments where alcohol can be purchased. Both sides submitted petitions.

Commissioner Maginn moved to uphold the local board's recommendation to deny the new permit. Commissioner Jones seconded. The motion was unanimously approved.

DL14-30910 ALL-STAR LIQUORS INC. – Chair Allen noted this is a request for a second extension.

Commissioner Maginn stated their local board hearing was continued so the current extension expires before the continued local board hearing.

Commissioner Maginn moved to approve the second 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

DL49-31588 TROY FOODS, INC. – Chair Allen noted this is a request for a second extension.

Commissioner Maginn stated there are issues with the ownership of this permit.

Commissioner Maginn moved to approve the second 90-day extension. Commissioner Jones seconded.

Vice Chairman Payne stated he does not understand why there continues to be problems with permittees not knowing the correct ownership and providing the Commission with that information. He would like permittees to be aware of the issue and to take care of it prior to needing additional extensions.

The motion was unanimously approved.

<u>RR22-39401 WILD EGGS OPERATIONS LLC</u> – Chair Allen noted this is a request for a second extension.

Commissioner Maginn stated there are issues with the ownership of this permit.

Commissioner Maginn moved to approve the second 90-day extension. Commissioner Jones seconded. The motion was unanimously approved.

<u>DL49-32456 VP51, INC.</u> – Chair Allen noted this is a request for a second extension.

Commissioner Maginn stated the Commission denied the renewal of this permit on June 18, 2024, for failure to appear at their 4 local board hearings regarding their violations. An appeal of the denial has been filed.

Commissioner Maginn moved to approve the second 90-day extension. Vice Chairman Payne seconded. Chair Allen approved. Commissioner Jones voted no. The motion passed 3-1.

INACTIVE FILES

Vice Chairman Payne moved to make 12 permits dead. Commissioner Maginn seconded. The motion was unanimously approved.

NEW BUSINESS

NON-RULE POLICY #32 – Chair Allen stated the Commission will be voting on a new policy that deals with conditional approval of permits where there are tax holds or a property tax clearance (Form 1)was not submitted, and the permits expire without those issues being taken care of. The proposed intent will be to give 30 days for the matter to be taken care of. The Commission will consider this at the August 6, 2024 meeting.

<u>UPDATED FORMS/LEGISLATIVE CHANGES</u> – The Commission has updated forms based on the legislative changes that went into effect on July 1, 2024.

- Retail and Craft manufacturers must provide proof of having liquor liability insurance.
- Businesses who are engaging in Happy Hour and To-go cocktails are expected to follow the proper procedures and to be compliant.
- The Commission mailed information and held webinars regarding the new legislation to prepare permittees, so compliance is expected. Alcohol is a regulated product and can be dangerous if not handled responsibly.
- Eighteen-year-olds are now able to obtain a restricted employee permit.
- Tobacco store clerks are now required to have a legal ID while working. Information regarding new tobacco laws was mailed to all tobacco certificate holders.

Noteworthy Violations for 7/1/24 Commission Meeting

RR4936274: Nite Owls LLC (DBA: Nite Owls) in Beech Grove, Marion County. In August 2023, the Marion County Task Force received a complaint from the Beech Grove Police Department regarding the number and nature of police runs to the business. Officers met with Beech Grove PD, reviewed calls for service at the business, and discussed the issues with the owners. A violation was written for public nuisance and falsification of records. The parties have agreed to a \$1,500 civil penalty, a 3-day suspension of the alcohol permit, and a placement on the PACE program.

<u>TC15181001</u>: Vape Paradise Inc. (DBA: Smoke Kingdom) in Indianapolis, Marion County. On April 4, 2024, District 6 Excise officers Matt Snyder and Haley Cox conducted a tobacco compliance check at the business. Officer Cox and the youth entered the business in plain clothes and the youth was able to purchase a Mr. Fog vape product without being asked for identification or a date of birth. The business has several prior violations for sale of tobacco products to a minor. The parties have agreed to a \$1,000 civil penalty and a 5-day suspension of the tobacco certificate.

<u>TC07319001</u>: Singh Oil & Gas Inc (DBA: Westedge Food Mart) in Topeka, LaGrange County. In March 2024, District 1 Excise officers received a complaint that the business was selling vape products to minors. On April 6, 2024, Officer Javier Arroyo conducted an investigation and observed the business sell cigarettes and vape products to two separate 16-year-old patrons. This was third known incident of sales to a minor in the past three years. **The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the tobacco certificate.**
