#### **MINUTES**

#### ALCOHOL AND TOBACCO COMMISSION

#### **SEPTEMBER 17, 2024**

#### CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

#### **DISPOSITION OF MINUTES**

Vice Chairman Payne moved to approve the minutes from the September 4, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

#### PROSECUTOR'S RECOMMENDATIONS

<u>PARTIES' AGREED DISPOSITIONS</u> – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Seventy-one dispositions were submitted with fines totaling \$38,650.00. Commissioner Jones seconded. The motion was unanimously approved.

#### HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

#### CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>DL49-33828 MOOSE LIQUOR II, LLC</u> – By consent, the Commission took the matter of this permit separately from the list of new and transfer permits for approval.

Chair Allen noted this transfer was scheduled for approval today, however, it appears there are criminal convictions by the owners that were not disclosed on the application.

Vice Chairman Payne stated the applicant disclosed that there are convictions but failed to provide documentation regarding those convictions.

Vice Chairman Payne moved to remand the transfer to the local board. Commissioner Jones seconded. The motion was unanimously approved.

Commissioner Jones stated if the information had been provided, the matter could have been taken care of earlier.

Chair Allen also made note that the local board is the entity responsible for vetting applicants, so if all of the information is not provided, it prevents the local board from properly vetting applicants.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Commissioner Maginn seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine shipper applications. Vice Chairman Payne seconded. The motion was unanimously approved.

#### WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

#### ITEMS FOR DISCUSSION

<u>RR84-01881 GREG A WILSON</u> – Chair Allen noted this is a renewal with the local board voting 4-0 to deny on remand. This was continued from the September 4, 2024 meeting.

Commissioner Maginn asked the permittee to provide receipts from the retailer showing the date and products purchased by this permittee. One receipt was submitted but was not sufficient based on the request.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR72-41490 5-7-10 LLC</u> – Chair Allen noted this is a new application with the local board voting 4-0 to approve. There was a remonstrator present at the local board hearing. The Chair informed the Commission that new information was received this morning from newly retained counsel for the remonstrator.

Commissioner Jones asked if counsel requested a continuance.

Chair Allen stated there is a request for continuance. Counsel provided an easement trying to show they were not previously disqualified from holding a permit because an easement meets the special qualification as a bona fide lease or some type of ownership

Chair Allen moved to continue this matter until October 1, 2024, to give time for legal research on the easement issue. Commissioner Jones seconded. The motion was unanimously approved.

<u>CH45-30242 SISTERS AND BROTHERS LLC</u> – Chair Allen noted this is a new application with the local board voting 4-0 to deny.

Commissioner Jones stated there is a problem with parking at this establishment. A proposal for 20 spaces was denied by the city. There is also a zoning issue. In 2023, the business was raided resulting in felony charges being filed on all four siblings for common nuisance. Alcohol was being served at that time.

Commissioner Jones moved to uphold the local board's recommendation to deny the new application. Vice Chairman Payne seconded. The motion was unanimously approved.

<u>RR49-41155 JOSE GILBERTO RUIZ LLC</u> – Chair Allen noted this is an application for a new permit. The application has been withdrawn.

Chair Allen moved to allow the withdrawal of the application. Commissioner Jones seconded. The motion was unanimously approved.

<u>RR49-33618 JOHALRAN INC.</u> – Chair Allen noted this is a renewal application with the local board voting 3-1 to deny.

Commissioner Maginn stated there was a shooting at the establishment. The owner was not present, and the only employee was in the parking lot asleep in a car. Alcohol was brought into the establishment by the patrons. There have been several police runs to the business. Also, Excise cited the business for falsification of records, dealing in unauthorized beverages, no employee permits, floor plan issues and no minimum food service. The Commissioner stressed that if a permit holder rents out their establishment to an individual, the alcohol permit holder is the responsible party if there are problems, not the renter.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

<u>RC48-27946 LOUIS MONROE POST #53, INC. AMERICAN LEGION</u> – Chair Allen noted this is a renewal application with the local board voting 3-1 to approve for one year. There were remonstrators present at the local board hearing.

Commissioner Maginn stated this establishment has been cited for violations. One of the remonstrators commented that there is not always minimum food service available.

Commissioner Maginn moved to uphold the local board's recommendation to approve for one year. Commissioner Jones seconded. The motion was unanimously approved.

RR19-34831 CALUMET LAKE EVENTS PLAZA LLC – Chair Allen noted this a request to reinstate. This permit was made dead for failure to renew. The permittee submitted a letter and a check stub, showing the renewal was filed in October, but the Commission has no record of receipt. After further investigation, the Chair found there is a catering hall permit (CH19-30036) at the location that continues to be renewed even though the permittee applied for and received a retailer permit with a catering hall designation because they wanted to be open to the public.

Chair Allen moved to conditionally approve the reinstatement provided the renewals are filed within 30 days and the catering hall permit (CH19-30036) is surrendered. Commissioner Maginn seconded.

Commissioner Jones asked for clarification that the reinstatement is conditional based on renewals being filed and the catering hall permit being surrendered within 30 days. Chair Allen stated that was correct.

The motion was unanimously approved.

Chair Allen noted there are other 210-1 permits available in this jurisdiction, so this has not prevented other individuals from applying for a beer, wine and liquor retailer permit.

<u>RR49-06959 H.A.T. ENTERPRISES, INC.</u> – Chair Allen noted this is on for an extension request continued from the August 20, 2024 meeting. The permittee requested this be continued.

Chair Allen moved to continue this to the October 1, 2024 meeting. Vice Chairman Payne seconded. Commissioner Maginn voted to approve. Commissioner Jones abstained. Motion approved 3-0 with 1 abstention.

RR87-22515 SEGOVIA, INC. - Chair Allen noted this is on for an extension request.

Commissioner Maginn stated this permittee has a history of serving minors. A corrective action plan was submitted stating an ID scanner has been installed.

Commissioner Maginn moved to approve a 90-day extension. Vice Chairman Payne seconded.

Commissioner Jones stated the expectation is that the scanner will be used because the minor service violations were not asking for an ID, not use of a fake ID.

The motion was unanimously approved.

RR71-37691 EL RANCHO VIEJO MISHAWAKA LLC – Chair Allen noted this matter is on following denial of the renewal for failure to appear at multiple escrow hearings as required. The permittee, through their attorney, provided information that they are working on a sale and due to changes in management, notices of the hearings were not received. The Chair stated this permit was placed on the auction list for the next auction, which has not occurred yet. In the future, removal from the auction list may not happen. After checking with the permittee, Chair Allen found that the Commission has the correct mailing address.

Commissioner Maginn moved to allow one additional opportunity to appear for an escrow hearing on October 22, 2024. Vice Chairman Payne seconded.

Chair Allen asked if the motion included reinstatement of the permit pursuant to compliance with Commission orders.

Commissioner Maginn stated it does.

Chair Allen commented that four different notices, including one mailed certified with certified green card signed and returned to the ATC, were sent to the permittee, at the time and expense of the Commission to get this moving. The only reason she is voting to reinstate is because the auction has not been held. The Chair stated she is becoming less and less patient with permittees who ignore the notices and later come back stating they are now ready to move this along.

Vice Chairman Payne noted that permittees not only ignore orders, but also requests for information and documents.

Commissioner Jones voted no. The motion was approved 3-1.

#### INACTIVE FILES

Chair Allen stated a request was made to remove RR49-36711 from the list of 14 permits to be made dead at today's meeting. By consent, this permit was removed and being discussed separately from the others.

<u>RR49-36711 LOS PATIOS MEXICAN RESTAURANT 2 LLC</u> - Commissioner Maginn stated there is a tax protest on this permit. The permittee has an agreed plan with revenue for payment. They also want to sell the business---not the permit---and use the proceeds to pay taxes and bring this permit into a current status for future use at a different location.

Commissioner Maginn moved to reactive the permit and place it in escrow. Commissioner Jones seconded. The motion was unanimously approved.

Vice Chairman Payne moved to make 13 permits dead that were posted on the September 17, 2024 meeting agenda. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen stated there are 12 permits announced today, to be made dead at the October 1, 2024 meeting.

#### **POLICY DETERMINATIONS**

NON-RULE POLICY #32 — Chair Allen noted there is one significant change on the policy, that being, instead of only having 30 days to clear taxes, permittees have 30 days to clear the taxes or contact us for more time and show us that you are working to clear the tax hold or fix the matter holding up the permit. Also, the Commission is announcing permits to be made dead at one meeting and adopting the list at the next meeting. Lastly, a hold is now visible on the commission list, to allow another indication for permittees to be notified of an issue.

Vice Chairman Payne commended Chair Allen for an excellent job working with the industry and using their input putting this policy together. He also stated that he will not be for any cases coming in that does not fit this pattern. The industry's input was incorporated, and they will have to comply.

Chair Allen stated the Commission does not want to take away permits for those who are actively trying to fix the problems. But there is a quota system for permits and if someone is holding and not using a permit, this prevents someone else from using it. Taxes being cleared and submitting a renewal are requirements for the issuance of a permit. Conditional approvals are not renewals. They are conditional upon the requirements being met

Commissioner Jones moved to adopt the policy. Vice Chairman Payne seconded. The motion was unanimously approved.

### Noteworthy Violations for 9/17/24 Commission Meeting

TC12398001: Marion Mart LLC (DBA: Marion Mart) in Marion, Grant County. On August 4, 2024, District 2 Officers Ben Fenstermaker and Tiffany Leer conducted an investigation at the business, specifically to see if they were selling tobacco products to minors. Officers observed a 19-year-old female purchase vape products and when approached, they determined she was intoxicated and possessed marijuana. The female told officers she regularly purchases vape products at the store and was subsequently arrested on numerous charges, including operating a vehicle while intoxicated and possession of marijuana. This was the third violation for sale of products to minor in the past five years. The parties have agreed to a \$1,000 civil penalty and a 3-day suspension of the tobacco certificate.

<u>TC10625001</u>: Tina Petroleum Inc. in Columbus, Bartholomew County. On March 31, 2023, District 4 Officer Corbin Smith conducted a permit inspection at the business. During the inspection, Officer Smith detected several counterfeit Mr. Fog vape devices. While on scene, the business could not locate invoices for the products in question. Violations were written for failure to retain invoices and public nuisance/tobacco. The parties have agreed to a \$2,000 civil penalty and a 10-day suspension of the tobacco certificate.
