



## **Commission** on **Improving** the **Status** of **Children** in **Indiana**

Dear fellow Hoosier,

It has been a year of tremendous growth and opportunity for the Commission on Improving the Status of Children. Following allocations made through the 2023 biennial state budget, we made several strategic investments. The position of Commission Coordinator was created, allowing us to better support and grow our network of hundreds of state employees and volunteers serving on our committees, task forces, and subcommittees. Additional administrative support was also brought to the Commission, allowing for better tracking of our activities, improved partner engagement, and the expansion of public-facing events and activities.

Most importantly, we have been able to continue expanding our work to integrate the voices of those impacted by state systems into our actions and recommendations. Our second cohort of Youth Representatives have joined the Commission, and we are growing the presence of youth on our task forces as well. A new partnership for the annual Day of the Child brought hundreds of school-aged Hoosiers to the statehouse to learn more about their government and the value of their voices. Looking forward, we are excited for our new Task Force on Suicide Prevention, Bullying, and Online Safety to begin its work. This group will be our first with the intentional goal of having youth and family voices on each of its subcommittees.

We are also proud to say that Indiana was one of only five states selected to participate in the Building Ecosystems Statewide for Thriving Youth Initiative of the Forum for Youth Investment. This three-year technical assistance program will be co-led by the Children's Commission and also includes the Department of Education, Department of Health, Division of Mental Health and Addiction, four youth representatives, and a parent representative collaborating on the issue of chronic absenteeism.

Lastly, we have been able to greatly increase the Commission's presence at the Indiana Statehouse. Building stronger, cooperative relationships with our legislators has improved our ability to shepherd recommendations through the legislative process, while also allowing us to link legislators to subject matter expertise and successful youth service program models.

It has been an honor to serve Indiana through the Commission on Improving the Status of Children over the past year, and I look forward to sharing even more successes in the future. When we all work together, there is no doubt that we can achieve everything our children deserve.

### Commission Meetings

State Fiscal Year: July 1, 2023 to June 30, 2024

#### August 2023

At its August meeting, the Children's Commission voted to approve the Youth Justice Oversight Committee's recommendation report. This report combined the recommendations of the YIOC subgroups including Behavioral Health, Data, Diversion, Grants Process, Juvenile Probation Standards, Screening and Assessment, and Transitional Services, while consulting a Youth and Family Advisory group. The presentation also mentioned that the Commission will maintain a relationship supporting the YIOC in its implementation and staffing of the recommendations. Commission Chair Senator Stacey Donato and Executive Director Mark Fairchild reviewed current legislative affairs practices and the need for a more formal process in the future. Mark was tasked with drafting a process to be presented at a future meeting. The Commission's Youth and Family Engagement Summit, themed "Unmuting Your Authenticity," is tentatively scheduled for December 1-2, 2024.

#### October 2023

At its October meeting, the Commission approved a set of legislative affairs guiding principles and agreed on the need for future approval of a legislative engagement agenda. These items helped guide the actions of the Executive Director during the Indiana General Assembly. Dejuna Rodriguez presented an update on the 2023 Family and Youth Engagement Summit titled "Unmuting Your Authenticity," planned by herself and Stephaney Knight. Finally, the Commission heard a presentation from Judge Kimberly Dowling on behalf of the Child Sexual Exploitation of Children subcommittee.

#### December 2023

At its December meeting, the Children's Commission finalized its legislative affairs and engagement plan. This plan listed the legislative topics relevant to

the Commission's strategic plan, additional issues suggested by members, and the activities to increase assistance to lawmakers. The Commission's coordinator and youth representatives recapped the 2023 Youth and Family Engagement Summit, sharing attendance statistics, highlights, and future summit plans. Next, Dr. Weaver and Kate Schedel presented the importance of the Youth Risk Behavior Survey. Last, the Commission's Task Force chairs recapped their work from 2023 and discussed future goals and projects.

#### February 2024

At the February meeting of the Children's Commission, members were provided with an update on legislative actions and engagement during the first half of the legislative session. Executive Director Mark Fairchild shared that many items impacting the health and safety of Indiana's children successfully became law. Also noted was how the increased presence of the Commission at the Statehouse provided opportunities to assist and educate legislators, opening the door to future cooperative opportunities. The Commission also heard a presentation from Monica Roose of the Indiana Birth Parent Advisory Board, with recorded contributions from two of its members, discussing the need to ensure parent voices are considered.

#### April 2024

At the April meeting, the Children's Commission heard presentations from the Division of Mental Health and Addiction about suicide, bullying, and social media and the Indiana Youth Services Association about prevention programming. The Commission also voted to approve the creation of a new task force on Suicide Prevention, Bullying, and Online Safety; heard updates on legislative actions during the 2024 session; and discussed future Day of the Child events. The meeting closed with recognition of the passing of Senator Jean Breaux, announcing the Commission internship to be renamed the Senator Jean Breaux Collaboration Fellowship.

#### June 2024

At the June meeting, the Children's Commission heard presentations from the Department of Health on the 2023 Youth Risk Behavior Survey, LifeSmart Youth on healthy teen relationships, and the

Indiana Youth Institute on the KIDS COUNT® Data Book. The Commission also heard updates on the Infant and Early Childhood Mental Health Subcommittee, the Bullying and Suicide Prevention and Online Safety Task Force, and Indiana's selection to participate in the Forum for Youth Investment's BEST Youth Initiative.

#### FAMILY & YOUTH ENGAGEMENT

All solutions are more effective if those who are expected to benefit from them participate in the process of developing them. The Commission continued and expanded our work to include lived-experience voices wherever possible.



#### 2<sup>nd</sup> Team of Youth Representatives Reflect

In July of 2023, the Commission welcomed as members two new young adults with previous experience with state systems. Julia Stumler and Aly Leonard immediately became great assets to the Commission, providing new perspectives and incredible energy that have taken our efforts to integrate and elevate lived-experience voices to new levels. Below are their thoughts on the first year of their two-year terms.

"I became a part of the Commission last year to help provide lived expertise to conversations surrounding children and families in Indiana. Incorporating experience from the receiving end of a system or program is an innovative way to employ change. My role on the Commission allows for just that—ideas, commentary, and innovation stemming from my own lived experience as a child facing the foster care system in Indiana.

My time on the Commission has been immensely rewarding. I have had the chance to lead but also the opportunity to learn. Being a part of the Commission furthered my understanding of leadership and using my own story to wield change. However, it also reminded me to sit back, learn. and listen in order to invite other stories of expertise to the table. To me, the collaborative spirit of the Commission is by far the most influential portion of this team. It has been an incredible space to work in, with legislators and changemakers constantly coming to the table with enthusiasm and compassion. It is a space where innovative ideas are welcomed by people from all backgrounds and beliefs. When I think of teamwork, I think of the Commission."

#### 2023 Youth and Family Engagement Summit

The Children's Commission hosted a two-day, virtual summit on December 1 and 2 on the theme of "Unmuting Your Authenticity." The summit had a goal of increasing and amplifying the voices of those with lived experience. Day one of the event focused on how professionals can build and encourage engagement, while day two focused on informing youth, parents, family, and community members on how they can use their voices to help make positive change for Hoosier youth. Each day opened with a lived-experience speaker setting the tone, with over a dozen lived-experience panelists, planners, and contributors helping to make the summit true to its goal.

### Day of the Child Expansion

The Commission supported a set of coordinated events at the Indiana Statehouse on President's Day 2024 in celebration of it being proclaimed "Day of the Child" by the office of Governor Eric Holcomb. The Marion County Commission on Youth welcomed hundreds of young advocates from around the state for the annual Youth Day at the Statehouse. Young Hoosiers

had the opportunity to see the Indiana General Assembly in action and share their voices at this engaging event.

In the Indiana House of Representatives chamber, the annual State of the Child kickoff event was hosted by the Indiana Youth Institute. State, federal, and local leaders and youth service providers gathered to learn how Indiana children are doing across the categories of family and community, health, economic well-being, and education. This event kicked off IYI's statewide State of the Child campaign, which includes more than a dozen in-person and virtual events this February through April to share the 2024 Indiana KIDS COUNT® Data Book.

# Indiana Selected for BEST Youth Initiative

Indiana is proud to announce its selection for the Building **Ecosystems Statewide for Thriving** Youth Initiative, a groundbreaking three-year program led by the Forum for Youth Investment. This initiative aims to enhance outcomes for youth ages 5-24 through collaborative, crosssystem approaches. According to the Forum for Youth Investment. Indiana was chosen for its commitment to improving youth outcomes through strategic system alignment, readiness to shift from reactive approaches to proactive cross-sector solutions, and dedication to engaging diverse voices, especially those with lived experiences.

Our state team brings together Indiana's Department of Education, Division of Mental Health and Addiction, Department of Health, Commission on Improving the Status of Children, and many other state agency partners. The team also includes individuals with lived experience, including four youth representing each system, and one parent, ensuring a diversity of perspectives. The three-year program began in the summer of 2024.

# Commission Coordinator Position Opens New Possibilities

In 2023, the Commission allocated funds for the position of Commission Coordinator. This staffing addition has allowed for better support of our task forces and committees, as well as greatly increased awareness of the Commission among stakeholders.

"Reflecting on my first year as the Commission's coordinator, a few major highlights come to mind. The addition of my position allowed for maintaining our existing task forces and committees and helping in the expansion of new ones. Supporting each group's needs included relieving co-chairs of administrative duties, maintaining lines of communication, and connecting the groups to their necessary audiences.

This allowed us to both be better informed about the issues that face Indiana's youth, as well as be active participants in discussions about solutions. Whether through supporting the Commission's youth representatives, adding parents and young adults to its task forces, or building community partnerships fueling our events and initiatives, my time as coordinator has helped strengthen our approach to community representation."
