Agenda and Notes:

Introduction and Check-In:

• Task force members introduced themselves to the new members, Kaylee May and Stephan Viehweg. Stephan introduced himself as an LCSW with the Department of Pediatrics/IU School of Medicine, and that he specializes in early childhood and infant mental health. Kaylee mentioned that she is a representative with lived experience in DCS and works with the Indiana Center for Recovery.

Review and Approval of Minutes:

• David requested a motion to approve the minutes from March's meeting. Jason Murrey motioned, and Jeannie Bellman seconded, and they were approved unanimously.

Updates/Old Business:

• For the Executive Director Update, Mark shared that there will be presentations from DCS on prevention initiatives and programs in the state, as well as suicide and bullying prevention from FSSA and DMHA. Mark acknowledged the Commission will discuss the formation of a group around bullying and suicide prevention but wanted insight from the task forces whose goals cross over with these issues. Task force members mentioned they have subgroups that are doing work within these areas, and that it may make sense to create a task force that unifies those subgroups or find ways to communicate and share information regarding efforts devoted to these issues.

New Business/Presentations:

- Mark asked the task force members if the use of "substance abuse" in its title is still preferred, to which members said "substance use" is the more acceptable terminology. Mark noted he will communicate that preference to the Executive Committee of the Commission.
- Gabriela shared that the evidence-based practice subcommittee is comprised of only herself, and that she will continue to advocate for MST regardless of the subcommittee's status but is wondering the approach the subcommittee should take regarding EBP's. The group discussed that it may be best to

widely promote the use of existing EBPs across the board and that steps should be taken to incorporate the economics of EBP implementation.
