#### **New Business**

• Eric Walsh, Umbaugh – Utility Rate Ordinance Information and introduction of Ordinance 834-2013 and Ordinance 835-2013

Eric Walsh of Umbaugh & Associates presented information regarding the need for a storm water utility to comply with the current IDEM agreed order. The proposed rate would be an additional line on utility customer's bill with the average residential bill at \$5.65 per month.

An increase in the water rate was also discussed. The proposed increase is necessary to provide the necessary funding for day to day operating costs, debt service payments, and capital improvements as a reinvestment in the system. The increase would add \$3.28 to the average residential water service bill.

A fire protection surcharge was also discussed. Currently, the public hydrants are paid for by the city's general fund. The proposed surcharge would spread the cost of the public hydrants to all utility users. The proposed rate would add \$3.08 to the average residential bill.

After discussion, it was determined that council would like additional information.

# **Comments by Members of Council and Administration**

Street Superintendent Mike Burdette: The department has been working with the park department on the splash pad project. Mike is working with the city engineer on putting an additional paving program together.

City Engineer Rick Pharis: The bid on the first paving program came in under projection allowing funding for additional projects. Rick is working with Mike to put together a list which will be prioritized and sent out for bids.

Fire Chief Jeremy Weaver: Jeremy presented his 2012 yearend report to council members. It highlights the department's statistics and projects for the year. Of note, 257 fire inspections were done in 2012. The remodel of the building is complete and department plans to hold an open house in May.

Public Safety Director Bryan Shearer: Recognition of public safety personnel for life saving efforts will be at the May 13 council meeting. Meetings with WN School superintendent were held to address safety concerns at the schools. Restructure of the school resource program to improve safety was discussed along with the sharing of responsibilities.

Park Director Alan Duncan: There are 18 soccer teams this year with 188 youth participating. There are 4 travel teams using the park's diamonds. Ground was broken on the splash pad and the "toys" will be arriving tomorrow.

Council Member Becky Gray: Thanks to Jeremy for the yearend report in a visual presentation

Mayor Patty Fisel: The plan commission was restructured and the new members have all been appointed. A meeting will be held on Tuesday, May 7 at 7:00 pm at City Hall for reorganization and election of officers.

The RDC met this morning. Structural Composites was present and the 5 jobs projected turned to 30. The RDC awarded the hotel feasibility study to Core Distinction Group of Minneapolis, MN who specializes in this type of study. The study is expected to take 30 days in will begin May 20, 2013.

Whispering Pines has completed the major cleanup of the old trailer park and will begin installing new park models.
