

## **CASS COUNTY COUNCIL**

**APRIL 20, 2012**

The Cass County Council met at 9:00 a.m. in the Commissioner Hearing Room. Present were George Stebbins, Ralph Anderson, Grover Bishop, Brian Reed, Jeff LeDonne, James David, Brent Kelley, Attorney John Hillis and Auditor Vaneen Ide.

George Stebbins called the meeting to order with the Pledge of Allegiance and a moment of silence.

### **MINUTES**

Ralph Anderson made a motion to approve the minutes as presented, Brian Reed seconded. The motion carried unanimously.

### **FAMILY OPPORTUNITY CENTER**

Judge Burns and Director Judy Hettinger were both present and appeared before the Council. Judge Burns requested additional funds in order to repair the roof at the Family Opportunity Center and for paving of the gravel drive. The roof is leaking and the temporary fixes are not sufficient. The drive is gravel and has holes the size of craters. The Commissioners gave a favorable recommendation to the Council for this expenditure at their April 16<sup>th</sup> meeting.

George Stebbins stated that the additional would probably be approved after it was properly advertised. This additional will be addressed at the May 18<sup>th</sup> meeting. The Council requested that the Auditor advertise it under County General, Rainy Day and Cum. Capitol in the amount of \$19,000.00

### **HEALTH DEPARTMENT**

Lynda Kennedy appeared before the Council with a request to transfer funds out of series for their cell phone contract. The amount being transferred from Supplies is \$3,800.00 and will be placed if approved into Other Services & Charges. Brian Reed made a motion to approve the transfer, Grover Bishop seconded. The motion carried unanimously.

### **PUBLIC COMMENTS – REGULAR MEETING**



The Cass County Council did not establish the Fire District. George Stebbins announced the Fire District #1 meeting will be continued to Friday April 27<sup>th</sup>. Grover Bishop made a motion to adjourn, Jeff LeDonne seconded. The motion carried unanimously.




