APRIL 19, 2013

The Cass County Council met at 9: 00 a.m. in the Commissioner Hearing Room. Present were Jeff LeDonne, Stacy Donato, Brian Reed, George Stebbins, Grover Bishop, James David, Brent Kelley, Attorney John Hillis and Auditor Vaneen Ide. George Stebbins opened the meeting with the Pledge of Allegiance followed by a moment of silence.

AMEND AGENDA

George Stebbins amended the agenda to omit items IV & V and add Cathy Collins – Partners for a Drug Free Cass County between the Treasurer and Airport.

MINUTES

George Stebbins requested that a change be made in the minutes. The vote for the wheel tax needs to be amended to reflect the proper vote count of five in favor and one opposed. The Auditor will make the correction before the minutes are posted to the website. Brian Reed made a motion to approve the minutes with the amendment to correct the vote count for wheel tax, Grover Bishop seconded. The motion carried unanimously.
