

ORDINANCE 2017-01, AMENDING ORDINANCE 08-02
AMENDED ORDINANCE OF THE CASS COUNTY COUNCIL TO ESTABLISH CASS
COUNTY RECORDER'S ENHANCED ACCESS FUND/FEE

Whereas, Pursuant to I.C. 5-14-3-8.3, the Cass County Council is authorized to establish an Enhanced Access Fund; and

Whereas, Pursuant to I.C. 5-14-8(h), the Cass County Council is authorized to establish an Enhanced Access Fee to be collected by the Cass County Recorder; and

Whereas, On February 15, 2008, the County Council originally passed Ordinance 2008-02 authorizing an Enhanced Access Fund and Fee to be collected; and

Whereas, Cass County has entered into a contract with a third party, Fidlar Technologies, to provide enhanced access to the public records of the Cass County Recorder's office; and

Whereas, the contract entered into with Fidlar also specifically outlines the fees charged by Fidlar to the County for providing said service; and

Whereas, the Cass County Recorder recommends that a fee be charged to the public for such access pursuant to said contract entered into under I.C. 5-14-3-3.5.

NOW, THEREFORE, BE IT ORDAINED BY THE CASS COUNTY COUNCIL AS FOLLOWS:

1. That there is a previously established Enhanced Access Fund #1154, for the deposit of fees received by the Cass County Recorder for providing enhanced access to the general public for access to the public records of the Cass County Recorder's office.
2. That there further is established a reasonable fee schedule for the Cass County Recorder for providing such enhanced access to the general public for access to the records of the Cass County Recorder's office, which schedule is attached hereto and incorporated herein as Exhibit "1".
3. That said fee(s) setout by a certain contract entered into between Cass County and Fidlar Technologies, also establishes a monthly subscriber fee and a single use fee.
4. That pursuant to I.C. 5-14-3-8.3, fees collected under this ordinance shall be used to cover/defray the cost for replacement, improvement, and expansion for such enhanced access to public records and such operating expenses incurred in providing such service. Said fees shall be deposited into the Recorder Enhanced Access Fund #1154.
5. That the purpose of this Amended Ordinance is to amend Ordinance 2008-02

This ordinance takes effect June 1, 2017
