### SHORT TERM GOALS (draft proposal, target to complete by by January 31, 2025):

1) Make recommendations to the Floyd County Board of Commissioners to distribute up to \$280,000 of opioid funding to support the needs of community organizations who serve Floyd County residents in one of four categories of prevention, treatment of addiction or mental health, after care, or supportive care for family.

**Status:** Recommendation made to Commissioners on 11/4/2024. What is plan for publication? **Follow up required after distribution:** Collect information from recipients for data collection and reporting to public of results of distributions and community impact. Possible use of Justice Counts. Formation of new finance committee and set role for finance committee.

- 2) Identify an appropriate provider of services for assistance with data collection and analysis for:
  - a. Collecting data from criminal justice partners and pertinent community partners that can be presented in a meaningful way.
  - b. Using the collected data analysis for review by JRAC and presenting to other agencies and funding sources to make determinations whether programming should continue or be changed to meet the community needs.

Status: JRAC approved onboarding. What are next steps?

3) Preparation of a Resource Guide to distribute to the community and for use by JRAC. **Status:** FCHD is finalizing with input from JRAC. Print to business cards for distribution timeline?

#### LONG TERM GOALS (draft proposal, set timeline):

- 1) For adults, to provide criminal justice involved individuals with interventions for mental health and substance use disorder treatment at each intercept in the local criminal justice system and to work together to identify and address any gaps.
- 2) For juveniles, to support existing community partners, criminal justice partners, and organizations who provide preventative measures, treatment and interventions for youth with mental health and substance use disorders and to work together to identify and address any gaps.
- 3) For individuals not currently involved in the criminal justice system, to support existing community partners and organizations providing prevention, family support, treatment, and interventions for adult and youth with

mental health and substance use related conditions in our community and to work together to identify and address any gaps in services.

- 4) Develop a Resource Inventory for our community
- 5) Should we Plan 2025 JRAC Mental Health and Addiction Summit??. Bi-annual event?
