 - A. Welcome Jordan Furnish, Cert. Peer Recovery Coach with Sunrise, newly appointed to serve on this subcommittee after appointment to FCCC-JRAC by Commissioners 7/2024.
- III. Approval of Minutes. Mot by Lorch. Second by Hodges. Unanimous Approval.
- IV. NEW BUSINESS
 - A. Creation of QR Code handout with list of community resources – Ann Carruthers (SOC) and Floyd County Health Department – HELP IS HERE. Discussion held. More to come. Charlotte and Hannah will partner with SOC to prepare.
 - B. SOC – Shared Google Doc for Trainings – Status. Discussion held on how best to gather trainings info and which to include. This subcommittee will email submissions to Amanda or upload on the google doc. Amanda will include a place for attendees to provide feedback and set categories.
 - C. Update from Judge Stiller on CEPP and Justice Counts (9/4/2024 at Noon) meetings. Discussion held. Judge Stiller investigating use of Justice Counts (a BJA/federal program) as a possible tool for data collection. Cass County, IN has been mentioned as a reference. Laura Elliott is familiar and has heard good things about this program. Judge will continue to review and report back. CEPP work ongoing also. They will assist JRAC in formulating short term and long term objectives for JRAC and use of opioid funding. We will use current application process in Moon work group as a test to see how the process goes for our purposes. We will also work to create performance measures with guidance from CEPP.
 - D. Dr. Katrina Norris, psychiatrist w/DMHA will be here with SOC in September. She may be available to attend our meeting but could have conflict with the probation training. However, after conclusion of meeting, we learned of several others with conflicts with our 9/5 meeting date due to probation and other trainings. Also, with the extension of the application deadline to 9/5/2024, Judge Stiller will cancel the 9/5/2024 meeting. Special meeting to be scheduled only if needed.
 - E. Update on Handle with Care mtg hosted by Yazel. All agreed this would not be a JRAC program bc specific to schools and law enforcement and up to them if they would want to pursue.
- V. Opioid Settlement Fund Work Group updates
 - A. Connie Moon – MH and Addiction Resource Support Work Group. Discussion about deadline. Moon raises concern about community having more time to submit their application. Mot to extend application deadline to 9/5/2024 by Lorch. Seconded and passed unanimously. Plan is to present to 10/3 subcommittee mtg with recommendations. Then recommendations will go to Full Board on 10/21/2024 mtg and to Commissioners on 10/22 at their meeting.

B. Magistrate Flanigan –Juvenile Initiatives Work Group. Beckwith provides report that they will be meeting with council for necessary approvals and then working to fill the position for the Juvenile Attendance Liason as soon as possible.
