Shawn Carruthers called the meeting to order and led the *Pledge of Allegiance*Shawn Carruthers led a moment of silence for our first responders, our children and community

Present: President Shawn Carruthers, Vice President John Schellenberger and Tim Kamer **Also Present:** Attorney Rick Fox, Judge Maria Granger, Council members Denise Konkle and Connie Moon

Scott Stewart presented a plaque to Shawn Carruthers and thanked him for service to the County and community.

New Business:

1. Approval of 2023 Annual Bids

Motion to approve the bids that were taken under advisement at the last meeting. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

2. River Hills-Chelsea Crump

a. ORCA Grant Application

Chelsea Crump presented the application for the Fairmount Neighborhood Center and reviewed the required documentation.

Motion to approve FCR 2022-25 Resolution Authorizing application submission and local match commitment. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

3. Lafayette & Greenville Fire District Attorneys- John Kraft & Steve Langdon

a. FCO 2022-41 Creating a New Combined Highlander Fire Protection District Attorney John Kraft from Young, Endres and Kraft and Bridget Cantrell from Church, Langdon, Lopp, Banet spoke on combining Lafayette and Greenville Fire Protection Districts to create Highlander Fire Protection District. Mr. Kraft stated that the Districts that have debt will remain in place until said debt is paid. After the debt is paid the District will be dissolved. There will be no duplicate taxing.

Tim Kamer stated he would like to see the impact to the Greenville stakeholders from DLGF before moving forward. He would not be able to vote in favor of this until he sees the tax study and some sort of information from DLGF to see what the tax impact is. He is ok with waiting until January. He does support the combining of the two fire districts but is hyper diligent on seeing the tax implications.

Mr. Kraft stated if this is not passed in 2022 then it will be moved to 2024.

John Schellenberger stated that both Fire Boards have passed this, have worked on this for months and feel they have done their due diligence.

Tony Jenkins, Greenville Fire Board, stated Reuben Cummings had completed a tax assessment and there was no impact for Greenville.

A meeting is scheduled on Tuesday, December 27 with Reuben Cummings in attendance to go over his calculations and to answer any questions they may have.

Closing Statements

John Schellenberger thanked Shawn Carruthers for his service to the County. He has been a full time Commissioner. In the past 4 years the Commissioners have made Floyd County a better place to raise our families.

John Schellenberger highlighted the Commissioners' accomplishments under Shawn Carruthers' leadership

- Paved and striped many county roads
- Rehab and built new bridges
- Increased the County park footprint with the purchase of the Regional park, purchase of the Jensen property, increased parking at Kevin Hammersmith Park and created the Accessible Playground and Splash pad
- They have been successful in obtaining 50 million dollars in READI grant, received over four million for Novaparke, invested in 4.2 million dollars for Broadband
- Invested with ARPA funds to upgrade water utilities and work with the Health Department to identify failing septic systems and extend package treatment plans to those subdivisions
- Provided responsible leadership during COVID pandemic by keeping the County open for business while safeguarding the employees and families
- Preserved 1.5 million dollars in the CARES Fund with fugal spending while requesting reimbursement from FEMA.

Mr. Schellenberger stated it was a pleasure and an honor to serve with Mr. Carruthers.

Tim Kamer stated Shawn Carruthers did an amazing job and appreciated working with him.

Attorney, Rick Fox, stated he has been representing the Commissioners for 16 years. He works closely with the Commissioner President and stated that Mr. Carruthers is at the top of the list when it comes to his professionalism and handling the business of Floyd County.

Shawn Carruthers appreciated all the kind comments. He is really proud of bringing broadband to Floyd County even before the pandemic hit, Novaparke, paving the roads, Kevin Hammersmith Park Accessible Playground, and the Floyd County transit plan. He stated these projects were a group effort, not just one Commissioner. He appreciates Tim Kamer, John Schellenberger and Rick Fox.

Council member, Denise Konkle, thanked Shawn Carruthers for his leadership and his humble servant heart.

Public

Heather Peters, Greenville, IN, stated she is confused that they were very thoughtful with the Stormwater issue but is trying to ram through the combining of two Fire Districts without any tax study. They are taking the recommendations from two appointed boards with no communication with the town councils of the two districts. She thinks it is a great idea but would like to see a tax study. She is concerned about all the tax increases that have been discussed. She stated she appreciates all that Shawn Carruthers has done for Floyd County.

Dale Mann, Georgetown, thanked the Commissioners for putting value in agricultural land.

Connie Moon, County Council, stated she is happy they are doing their due diligence on the Fire Department.

She stated she has been working on the Opioid Committee with Tim Kamer. She has had a huge response from inside and outside county government to come together to give their insight on how to spend the money. She hopes the Commissioners will pass the same ordinance as the County Council.
