Shawn Carruthers called the meeting to order and led the *Pledge of Allegiance*

Present: President Shawn Carruthers, Vice President John Schellenberger and Tim Kamer **Also Present:** Attorney Rick Fox, Assessor James Sink, Auditor Jacqueline Wenning and Councilman Dale Bagshaw

Shawn Carruthers led a moment of silence for the men and women of the military and fellow citizens affected by the hurricane.

Old Business:

- 1. County Attorney-Rick Fox
 - a. FCO 2022-31 Travel Lodging Reimbursement TABLED

Motion to table. Moved by Tim Kamer. Seconded by John Schellenberger. Motion passed unanimously.

New Business:

- 1. Building Authority-Scott Stewart
 - a. 2050 Project Update

Scott Stewart stated the City County Building opened 61 years ago on Oct 18. It has been a challenge for the past 10 - 20 years on how to stretch the useful life of the infrastructure while ensuring the continuity of the central services.

Chuck Edwards, Superintendent of City County Building, stated all the building's electrical, plumbing, mechanical and other systems have surpassed their useful life by 30 years. The building has served the county well but the systems are obsolete and parts are no longer available. If the building is renovated it will need to be evacuated due to asbestos. His professional opinion is the cost to keep the building running and comfortable is estimated to be \$700,000.00 – 800,000.00 per year for the next 10 years if the renovation does not take place.

Scott Stewart asked the Commissioners to keep all of this information in mind when considering the building projects for the Judicial Center and administrative offices.

2. River Hills-Chelsea Crump

a. Environmental Review for Fairmont

Chelsea Crump stated River Hills is assisting Rauch with their application for the Fairmont Neighborhood Center renovation project. They are applying through the Office for Community and Rural Affairs for a public facilities program. Rauch has held two public hearings and will hold two more. The total cost for the project is \$537,580.00. Rauch can apply up to \$333,837.00 in grant funds and will cover the remaining amount.

The project will include an accessible sidewalk, installation of covered awning, replace chain link fence with vinyl fencing, paint interior and exterior of the building, installation of a new roof, enlargement of entrance doorway to accommodate wheelchairs, replacement of flooring throughout the building, remodel of kitchen and bathrooms and replacing HVAC systems throughout the building.

Motion to approve River Hills Economic Development District and Regional Planning to prepare and submit the minutes that are required for the Community Development Block Grant. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

3. Floyds Knobs Water Company-Danny Standiford

a. Bridge Inventory Report

Jon San Giorgio reviewed the bridge inspection report completed in April 2022.

5. Director of Operations-Don Lopp

a. FCO 2022-32 - Speed limit - Charlestown Road

FCO-2022-32 reduces the speed limit on Charlestown Road from Lewis Endres Parkway to County Line Road to 35 mph.

Tim Kamer reminded citizens that the Commissioners did put a burn ban in place. He wished everyone a very safe, happy and spooky Halloween.

Rick Fox stated elections are open and to check with the Clerk's Office to check schedule and vote early.

Public:

Dale Mann, Georgetown Township, stated he likes the new voting machines. He commended on the condition of the City-County Building and that the condition is not as costly as was presented. He suggested putting it in a referendum to the public to see if they want to spend the money.

Mr. Mann asked them to look at removing the stop sign on John Pectol Road at Hamby Road. He is not in favor of subsidizing the internet companies so they can offer lower rates. He stated we are behind the times.

Brian Taylor, lifetime resident of Floyd County, thanked the Commissioners for their service. He asked for a new or better noise ordinance. John Schellenberger stated it is difficult to enforce noise ordinance without micro managing. He suggested speaking to the neighbor but Mr. Taylor stated he has spoken to them and they are not willing to work with him.

Rick Fox stated he was involved with the City of New Albany Noise Ordinance and the Floyd County Noise Ordinance. They did away with the decibel issue because, from a legal standpoint, you have to prove the machine you are measuring decibels is properly calibrated within a certain period and that the individual is certified. A police officer can use their discretion if they will issue a ticket.

Tim Kamer stated if they enforce restrictions they will be contacted by others that they cannot use, for example, their dirt bikes on their own property.

Mr. Taylor stated he could not entertain guests on his back deck because of the noise problem from one neighbor.

Motion to adjourn. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.
