## 3. Commissioner-Jason Sharp

a. FCO 2023-45 Floyd County Animal Care and Control Ordinance

Jason Sharp thanked the people that helped vet and review the ordinance, April Mentor and Alyssa Underwood with Animal Protection Association and Elizabeth Starck, Southern Indiana Animal Rescue. He named the project after his pet Shih Tzu, Elvis to help him to focus on the importance of the standard of care for animals.

April Mentor stated she is thankful Floyd County decided to redo the outdated ordinance for the animals in the county.

John Schellenberger stated it is a well written document.

Al Knable stated it is a very timely update as population density changes.

Jason Sharp stated the five person board will be made up of a veterinarian, member of the Health Dept., law enforcement officer and two lay people from the community.

b. Animal Control Contract

Jason Sharp stated the provider for Animal Control in Floyd County is New Washington Animal Control Services. Mr. Draper stated the shelter is off of State Road 62 in Jeffersonville.

c. RFP Pre-Hospital Care Emergency Medical Ambulance Services for Floyd County not to Include the City of New Albany

Jason Sharp thanked the members of EMS Advisory Board to create the RFP. John Schellenberger stated, as a member of the Advisory Board, that they have a good cross section of experience and believe they have done their due diligence.
