Aaron Combs said it is an increase of 2.9% over last year's budget. Bill Fender said to keep in mind when the City of New Albany Police Department moves out that the County will be responsible for the entire rent including the 9% that the Police Department pays now. The operating budget for 2025 is \$1,643,436.00 and an additional \$540,000.00 in for Capital expenditures. A lot of the systems in the building are at the end of useful life. The building appraised for a little under \$18 million.

John Schellenberger said, "We are now one month into the new EMS contract. This morning, I stopped at the Lafayette Fire House and talked with Brandon Alexander to get an update. All is going well, last week they responded to a mutual aid call backing up Ameripro responding to the carbon monoxide event at Ace Hardware, making several runs transporting to Baptist Floyd Hospital.

Brandon indicated Baptist Floyd is coordinating an Audit Review Committee comprised of the representatives from ambulance providers Ameripro, Highlander and Harrison County EMS providers that transport patients to Baptist Floyd. Baptist Floyd representatives from those disciplines along with Dr. Pahner-our EMS medical advisor, will be attending.

Their main focus will be cardiac patients, neuro patients-stroke, trauma patients and pediatric patients."

He gave a shout out to the Highlander Fire, Georgetown Fire and Palmyra Fire. There was a structure fire on Pekin road about a mile from home. Palmyra responded with a tanker, in

addition to tankers from Highlander and Georgetown Districts. The Highlander engine was at the fire scene and their pumper worked with the tankers to make sure there was ample water available. The house was destroyed but no one was in the house and no injuries. This was a great firefighting effort by our local firefighters.

He wished all to have a safe and enjoyable 4th of July.

Jason Sharp wished everyone a happy and safe July 4th. He said it is important to have working smoke detectors in the homes and close doors before going to bed.

Al Knable said to enjoy a safe celebration.
