b. Ramsey Water ARP

Don Lopp said Ramsey Water had two projects. One of the projects was with Town of Greenville. They are unable to obtain the land for the project. They are requesting formally to move \$60,000.00 from that project into their water main project that goes through the Town of Georgetown. There will be formal documentation at the next Commissioners Meeting.

c. SBOA Compliance

Don Lopp said the Compliance Report was submitted to SBOA in January. The report was approved in error after some communication with the State Board of Accounts and communications internally with the Auditor and the Department of Highway and Public Works. Mr. Lopp is submitting it back to the Commissioners. A draft was submitted to SBOA and they said it was appropriate and they would sign off on it. He said there are three tranches of funds that Highway and Public Works are paid out of. They will be paid out on a percentage basis, on a monthly basis. They will be reviewed each month by himself and Ms. Topping to make any payroll corrections at the end of each month.

d. Paoli Pike Corridor Study Update

Don Lopp said an \$100,000.00 reimbursable grant was received through KIPDA to study the Paoli Pike corridor from Altawood to the Post Office for either a trail or some type of sidewalk system to allow for pedestrian travel. He credited Mr. Creevy for his work on this project. The County will be reimbursed for 75%.

- e. Edwardsville School Project Update
- Don Lopp stated the traffic light is approximately 3 weeks to completion. The project should be complete and operational by the end of May.
 - f. Old Vincennes Road Update

Don Lopp stated REMC has started their work. Signage has gone out. Also, notifications along the corridor went out. They are directing people to the website for more information. The work will begin June 1.

g. Operations- Facilities

Don Lopp reviewed the Facilities Overview. There are four employees with a budget of \$402,000.00. Maintenance has five buildings and mow 20 acres during the summer. The Custodial staff has five buildings to service.

h. Town of Georgetown Property Request

The Town of Georgetown is requesting property at the west end for the Town Park project at Georgetown Lanesville property line. They are getting a deed together to close out their project and allow them to start work.

i. Envoy Contract Amendment

The changes are for additional engineering work and structural engineering cost.
