**RESOLUTION TO PURCHASE A 900-ECO 9 YARD
TRUCK MOUNTED COMBINATION SEWER
CLEANER**

WHEREAS the Floyd County Stormwater Board passed a Resolution requesting that the Floyd County Commissioners purchase a 900-ECO 9 Yard Truck Mounted Combination Sewer Cleaner from Brown Equipment Co., 2501 South Kentucky Avenue, Evansville, IN 47714.

WHEREAS IC 36-1-4-5 states that a unit may acquire and own personal property.

WHEREAS the Floyd County Stormwater Board needs the equipment identified in this Resolution to service the needs of the residents of Floyd County.

WHEREAS the Floyd County Stormwater Board gave a Notice to Bidders with a bid deadline of March 7, 2023. Bids were received, opened at a public meeting and rejected by the Stormwater Board.

WHEREAS the Floyd County Stormwater Board gave a second Notice to Bidders with a bid deadline of October 3, 2023. Bids were received, opened at a public meeting and rejected by the Stormwater Board.

WHEREAS the Floyd County Stormwater Board recommends that the Floyd County Commissioners purchase the 900-ECO 9 Yard Truck Mounted Combination Sewer Cleaner.

WHEREAS the Floyd County Stormwater Board received a bid of \$489,931.49 through a Sourcewell awarded contract through Sewer Equipment Co. of America and Brown Equipment Co., Inc. The cost of the unit is \$489,931.49.

WHEREAS pursuant to IC 5-22-10-2, a special purchasing agent may make a purchase under this chapter without soliciting bids or proposals notwithstanding any other provision of this article.

WHEREAS pursuant to IC 5-22-10-8, the purchasing agent may make a special purchase when the compatibility of equipment is a substantial consideration in the purchase. The Floyd County Commissioners finds that the purchase of this unit is a substantial consideration in meeting the compatibility of Floyd County's needs.


WHEREAS pursuant to IC 5-22-10-12, the purchasing agent may make a special purchase when the market structure is based on price, but the governmental body is able to receive a dollar or a percentage discount of the established price. The Floyd County Commissioners find that this purchase price is based on market structure and the county is receiving a discount. The discount is \$40,791.61.

WHEREAS the Floyd County Highway Department also has a need for the equipment identified herein.




