

HOWARD COUNTY COUNCIL REGULAR MEETING MARCH 28, 2017

The Howard County Council met in Regular Session on Tuesday, March 28, 2017, at 4:00 p.m. in Hearing Room 338 of the Administration Center. Those in attendance included President Richard Miller, Vice President James Papacek, and members Les Ellison, Jeff Stout, Stan Ortman, and John Roberts. Also in attendance were County Attorney Larry Murrell, Assistant County Attorney Alan Wilson, and Auditor Martha Lake. Councilman Dwight Singer was not in attendance.

The meeting was called to order by Sheriff Steve Rogers and conducted by President Richard Miller. President Miller led in the Pledge of Allegiance and Mr. Ortman offered a word of prayer with special remembrance and thanks to our veterans.

IN THE MATTER OF RESOLUTION NO. 2017-HCCR-06:

Mr. Miller submitted Resolution No. 2017-HCCR-06, a resolution of the Howard County Council honoring Martino's Italian Villa upon its induction into the Pizza Hall of Fame. He read the resolution into record as follows:

WHEREAS, Frank and Angela Martino were born in Italy and immigrated to New York with their families in the late 1940's. After their marriage, Frank and Angela moved to Kokomo and established Kokomo's second pizza restaurant in 1962 at the corner of Phillips and Jackson Streets; and

WHEREAS, they later moved their restaurant to North Main Street, and in 1972, with business booming, they built their current eatery at 1929 N. Washington which quickly became, and continues to be, a favorite spot for their many loyal customers; and

WHEREAS, son Mike began working in the family business at age 9 along with his three siblings; and since Frank's passing in 2004, Mike and Angela continue to operate the restaurant where every morning they prepare the pizza crust and sauce from scratch, season the sausage and grate the cheese;

WHEREAS, in recognition of this rich family history and iconic status in the community, Martino's Italian Villa was this month inducted into the National Pizza Hall of Fame, which was established in 2005 by PMZ Pizza Magazine to showcase legendary pizzerias; and

WHEREAS, by receiving this recognition, Martino's now takes its place beside dozens of iconic East Coast eateries such as New Jersey's Santillos Brick Oven Pizza and Patsy's Pizzeria, a local haunt in New York City's East Harlem that was frequently patronized by Frank Sinatra;

NOW, THEREFORE, BE IT RESOLVED BY THE HOWARD COUNTY COUNCIL AS FOLLOWS:

1. Martino's Italian Restaurant is hereby publicly recognized and honored for its induction in PMZ's National Pizza Hall of Fame.
2. Angela and Mike Martino, together with their entire family and dedicated staff, are to be commended for their exemplary work ethic and family values, which are a treasured asset to all of Howard County.
3. In honor of this remarkable accomplishment, the Council hereby declares and dedicates March 28, 2017 as "*Martino's Day*" in Howard County, Indiana.
4. A copy of this Resolution shall be delivered to Mike and Angela and shall be made a part of the official records of the Howard County Council.

Sheriff Rogers commented that the jail population has continued to increase since the new sentencing structure and Howard County holding level six felons at the Criminal Justice Center. This has forced the Sheriff to house Howard County inmates in other facilities, thus, the need to increase the Care of Inmates in Other Institutions line item. The fixed bed capacity is three hundred sixty-five (365). The current jail population is four hundred nineteen (419). Thirty-Nine (39) have been sent to other counties. Auditor Lake continued to explain that Howard County is currently holding state prisoners and we are paid by the Department of Correction. That money is being receipted into fund 1114 and Ms. Lake believes that the expenditure to house Howard County inmates outside of Howard County should also come from 1114 to be consistent.

A motion was made by Mr. Papacek to approve the request of \$320,000.00 in line item 33740, Care of Inmates in Other Institutions. The motion was seconded by Mr. Stout and carried.
