

HOWARD COUNTY COUNCIL REGULAR MEETING JUNE 28, 2005

The Howard County Council met Tuesday, June 28, 2005 at 7:00 p.m., in Room 338 of the Howard County Administration Center. Those present were Council President Richard Miller, Council Vice President James Papacek and Council Members Dwight Singer, Jr., Stan Ortman, Leslie Ellison, Jeffrey Stout and Joseph Pencek. Also present were County Attorney Larry Murrell and Auditor Ann Wells.

The meeting was called to order by Sheriff Marshall Talbert and conducted by President Richard Miller.

The minutes of the May 17, 2005 Regular Meeting, having been previously reviewed, were considered and approved as submitted on a motion made by Mr. Singer, seconded by Mr. Ortman and carried.

IN THE MATTER OF COUNCIL OPENING COMMENTS:

Mr. Papacek thanked Sheriff Marshall Talbert for stationing a Deputy at 100 South and Highway 31, to monitor the traffic. Sheriff Talbert responded by informing the Council of the Department's intention to have "Blitz Days", where several times a week, Administrators from the Sheriff's department will spend time on the streets monitoring traffic.

Mr. Papacek publicly expressed congratulations to the Eastern Comets girls' softball team on the victory in the State Finals, and also to the Northwestern boys' baseball team as runner up in the State Finals.

Mr. Miller congratulated Sheriff Talbert on the tactful way he fielded questions pertaining to the rash of burglaries, during a recent radio interview. Congratulations were also issued to Sheriff Talbert and the department's deputies in the success of solving those burglaries. Sheriff Talbert responded with appreciation from him and his department.

Community Corrections Director, Steve Maus, was in attendance to inform the Council of the Community Transition Placement Fund (923). The program is set up to work early-release inmates into the Community Corrections Department and is paid by the state on a per diem basis. This budget includes a \$500.00 salary increase. Project Income Fund (924) is a user fee funded program and also includes a \$500.00 salary increase. All other budget figures are the same as last year. The Community Corrections Grant (925) includes the \$500.00 salary increase (the \$500.00 salary increases were the same bonuses given to all county employees eighteen months earlier); all other budget amounts are the same as last year with the exception of a few new line items. Fund 924 also includes a budgeted item of home monitoring equipment. The equipment needs to be replaced, however, Mr. Maus is not certain if it will be leased or purchased, at this time.

A motion was made by Mr. Stout to approve the budget requests as submitted for 923 Community Corrections CTP Fund in the amount of \$80,613.00, Project Income Fund 924 in the amount of \$386,227.00 and Community Corrections Grant Fund 925 in the amount of \$214,292.00. The motion was seconded by Mr. Singer and carried.

Commissioner Bagwell and Terry Tribby, Information Systems Director, informed the Council of the need for the requested transfers in order to set up a new account number, 01112.01, Network Technician. Mr. Bagwell called the Council's attention to the facts that we have over \$5 million dollars worth of computer equipment and software in the county, and the ever increasing need for more technicians to care for the equipment. Transferring into the listed accounts would make funds available to support a full time position for the remainder of the year. The transfer is from line item 03120.02 Contract Services to line item 01114.00, Part Time. Mr. Bagwell explained that they would like to keep line item 01114.00 as Part Time and have the \$1,700.00 transferred into a new number, 01112.01, Network Technician.

Discussion ensued concerning how this position would be financed in year 2006 and the 90-95% rule now in effect. Both of these concerns will be addressed at the next PAC Committee and Commissioner meetings. A motion was made by Mr. Ortman, seconded by Mr. Ellison and carried to approve the transfers for Information Systems listed above.

After some discussion concerning the need for an extra fulltime employee versus the funds to pay the employee, a motion was made by Mr. Papacek to approve Ordinance No. 2005-HCC-31, Amending the Salary Ordinance, with the change in the Information Systems Request as noted. The motion was seconded by Mr. Stout and carried.

IN THE MATTER OF SB400 UPDATE – DEPARTMENT OF CHILD SERVICES:

As a requirement of Senate Bill 400, Circuit Court Judge Lynn Murray and Indiana Department of Child Services Director, Roger Suhre, were in attendance to submit a report to the Council of county funds used for Juvenile services. The report was distributed and clarified by Mr. Suhre, concerning actual expenses and estimated expenses through the remainder of the year. The new state administration has instituted certain changes to help organize the

system into smaller regions. These new regions are based on State Police post locations and require additional staff. Howard County is now in a region of five counties in lieu of the former sixteen counties.

IN THE MATTER OF RESOLUTION NO. HCC-2005-14:

Mr. Glen Boise, Plan Commission Director, presented Resolution No. HCC-2005-14, declaring an interest in purchasing a residential flood plain property. The property is located at 4089 South CR 50 East, Kokomo, Indiana, and was one of the six properties that were severely damaged in the 2003 flood. Funding has now been received to purchase the home, and then demolish it. This property is the third property to be purchased by the county this year, with three more to purchase when funding is available. Twelve other properties have been identified as being in the flood plain and are targeted for future purchasing. Mr. Boise and Commissioner Bagwell clarified the concept of flood plain and what is being done to help the flooding problem, as well as updating city and county zoning ordinances. Also clarified was the county's responsibility in matching funds and excavation costs, and appraising the home's value.

A motion was made by Mr. Papacek, seconded by Mr. Stout and carried to approve Resolution No. HCC-2005-14.

County Attorney Murrell commended the job that Mr. Boise is doing, concerning the administration of the home purchases.

IN THE MATTER OF BUDGET REQUEST INFORMATION ON DONATIONS TO THE NORTH CENTRAL INDIANA SMALL BUSINESS DEVELOPMENT CENTER:

Ms. Mary Giangiardano, Regional Director for the Small Business Development Center, presented a report of the usage of funds provided by Howard County, and the request for budget year 2006. Ms. Giangiardano expressed thanks to the Council for their support to the Small Business Development Center and the incredible year they experienced in 2004. She also clarified the services that the Center offers to local businesses, including (1) consulting services, (2) seminars, conferences, and workshops, and (3) loan clinics to provide funding options. Ms. Giangiardano made a request for funds in the amount of \$12,500.00 for the year 2006.

IN THE MATTER OF SHERIFF DEPARTMENT CONCERNS:

Sheriff Marshall Talbert submitted the following issues for Council information and approval:

1. Sheriff Talbert distributed copies of the **Commissary Fund Report** to the Council members.
2. Sheriff Talbert will be presenting a request for **Additional Appropriations in the Inmate Medical** line item in the coming months. He went on to describe a medical situation involving an inmate and the near death experience he underwent. Sheriff Talbert commended his staff for being able to avert a possible inmate death while incarcerated.
3. **Three new unpaid reserves have been added to the Sheriff's Department**, now making the total four. They have been sworn in and will be receiving their uniforms.
4. Sheriff Talbert submitted a **check from the Health Department in payment for ID badges** made by the Sheriff's Department.
5. **The Deferred Retirement Option Program (DROP) was submitted to the Council**, and explanation was made by Sheriff Talbert. A number of State Police Officers are involved with this program and doing well. By consensus, the council decided to take this issue under advisement until the July 2005 meeting.

There being no further business to come before the Council, a motion was made by Mr. Papacek, seconded by Mr. Stout and carried to adjourn. The meeting was adjourned at 8:15 p.m.
