

HOWARD COUNTY COUNCIL REGULAR MEETING AND 2014 BUDGET SESSION
AUGUST 20, 21, 22 AND SEPTEMBER 4 AND 12, 2013 MEETING:

The Howard County Council met in Regular and 2014 Budget Session on Tuesday, August 20, 2013, in Hearing Room 338 of the Administration Center. Those in attendance included President Richard Miller, Vice President Stan Ortman, and Members Jeff Stout, Leslie Ellison, John Roberts, and James Papacek. Councilman Singer was not in attendance. Also in attendance were County Attorney Larry Murrell and Chief Deputy Auditor Laurie Martin. Auditor Martha Lake was not in attendance due to a family emergency.

The meeting was called to order by Captain Jerry Asher and conducted by President Miller. Councilman Roberts led in the Pledge of Allegiance and Mr. Miller offered a word of prayer.

IN THE MATTER OF APPROVAL OF MINUTES:

The minutes of the July 23, 2013, Regular Meeting were previously submitted and reviewed. The minutes of the Howard County Joint Special Session of the Howard County Board of Commissioners and the County Council were submitted. The Special meeting was called in order to review and discuss the information and recommendation given by Crowe Horwath concerning the Consolidated Dispatch. Both sets of minutes were approved as submitted on a motion made by Mr. Papacek and seconded by Mr. Ortman and carried.

Buildings & Grounds Superintendent Scott Reed informed the Council that there have been several major issues at the Criminal Justice Center concerning the air conditioning system and other aging equipment repair expenses. There is not enough money left to fund a monthly repair expense of \$6,000 through the end of the year.

A motion was made by Mr. Papacek to approve the additional request of \$34,000.00 to line item 03253.01, Equipment Repair – Jail. The motion was seconded by Mr. Stout and carried.

KYC Director Jeff Lipinski informed the Council that at the beginning of 2013 one of the full-time shift supervisor's positions was changed to include resident transports and weekend supervising (some of his salary being paid from different

line items). This frees up some funds that are needed in the Part Time line item. The transfer into the Equipment Line item is to purchase a much needed fax-printer-copy machine.

A motion was made by Mr. Ortman to approve the transfer request as presented with the change of the line item name to Part Time Shift Supervisor, in lieu of Overtime Nurse. The motion was seconded by Mr. Roberts, and carried.

A motion was made by Mr. Stout to approve the Salary Ordinance as presented with the change in the name of line item 01119.02 to Part Time Shift Supervisor in lieu of Overtime Nurse. The motion was seconded by Mr. Ellison and carried.

IN THE MATTER OF THE SUBMISSION 2014 BUDGET REQUESTS:

Several 2014 Budget Requests were submitted as follows:

Convention and Visitor's Bureau: Greater Kokomo Economic Development Alliance President and CEO, Mr. Chris Hamm, submitted the CVB 2014 Budget. Mr. Hamm reviewed the Budget with the Councilman, reflecting an increase of about 24% over the 2013 budget. Comments of clarification were given by Ms. Kim Morgan of the CVB.

Superior Court I: Judge William Menges submitted the 2014 Budget Requests for Superior Court I and Unified Courts (County General), Community Based Drug Free Fund (1148), and the Jury Pay Fund (2512). He reviewed the requests with the County Council and fielded questions from the Council members.

IN THE MATTER OF THE KINSEY YOUTH CENTER VEHICLE PURCHASE REQUEST:

Kinsey Youth Center Director Jeff Lipinski submitted a request to purchase a used vehicle from the Family Functional Therapy Fund. The Fund is up to \$100,000 and can support the vehicle purchase. The Vehicle would be used for FFT appointments, making it a purchase that would comply with the guidelines for fund usage. The purchase of a 2009 Chevrolet Malibu from Button Dodge, in the amount of \$13,790.00, was approved by the Board of Commissioners at their August 19th meeting. Mr. Lipinski also informed the County Council that as of June 30, 2013, Kinsey Youth Center has returned \$829,865 back to the Jail & Juvenile COIT Fund. He estimates that number will increase to \$1.2 to \$1.4 million by the end of 2013. This is due to a lot of out-of-County services. Mr. Lipinski fielded questions and at its conclusion, a motion was made by Mr. Roberts to approve the vehicle purchase request from the Family Functional Therapy Fund. The motion was seconded by Mr. Ortman and carried.

IN THE MATTER OF ORDINANCE NO. 2013-HCCO-16:

Recorder Brook Cleaver submitted Ordinance No. 2013-HCCO-16, an ordinance of the Howard County Council to establish the Howard County Recorder's Enhanced Access Fund. This fund is created to hold fees collected for access to certain public records maintained by the Recorder. A third-party vendor has been contracted to provide the enhanced access and to establish a reasonable fee, to be divided between the vendor and the Access Fee Fund. A motion was made

by Mr. Papacek to approve Ordinance No. 2013-HCCO-16, establishing the Howard County Recorder's Enhanced Access Fund. The motion was seconded by Mr. Ortman and carried.

IN THE MATTER OF THE SHERIFF'S PENSION PLAN CHANGES:

Ms. Loretta Moon, Head Matron and Personnel Director of the Howard County Sheriff's Department, submitted and reviewed with the Council a Restatement and Submission of the Sheriff's Pension Plan that will incorporate the legislative and regulatory changes made since the last statement. County Attorney Murrell and Auditor Lake have reviewed the "Restatement". A motion was made by Mr. Papacek, seconded by Mr. Roberts and carried to approve the Restatement and Submission of the Sheriff's Pension Plan, and authorize the President to sign on behalf of the County Council.

IN THE MATTER OF THE VETERANS MONTHLY REPORT:

Retired Colonel Ross Waltemath reviewed the Veterans Service Office Monthly Report for the month of July, 2013, with the Council members. He mentioned the ¾ of a million dollar amount of disability compensations to veterans. Also of note was the re-institution of the Veterans Community Council. Once a month representatives of the nine Howard County Veterans Service organizations, the Family Service Association, the Mayor's office and the County VSO office will meet to address the gaps and needs of veterans in our community, by identifying and meeting the needs using community resources. Administrative Assistant Selma Bliss will be retiring from the VSO Office the end of August, 2013. Mr. Waltemath invited the Council members to stop by the office and thank Ms. Bliss for her service to veterans.

Council President Richard Miller began the budget session with a word of prayer.

IN THE MATTER OF THE AMENDED SB-1 AND AMENDED ECONOMIC DEVELOPMENT AGREEMENT FOR THE WILDCAT WIND FARM LLC:

Howard County Attorney Larry Murrell gave a brief synopsis of the discussions with E.ON concerning the Wildcat Wind Farm, as well as the four months of public comments given by citizens concerned with the future installation of wind turbines and Eastern Howard County. Ms. Mary Solada, attorney with E.ON spoke to the Amended form SB-1, setting forth the minimum potential investment for Phase II and Phase III of the project. At the completion of Ms. Solada's presentation, Commissioner Paul Wyman outlined the amendments to the EDA. Copies of the Amended SB-1 and Economic Development Agreement were distributed to the Councilmen for their review and consideration. Later in the meeting, a motion was made by Mr. Stout to approve amended SB-1 for the Wildcat Wind Farm LLC. The motion was seconded by Mr. Singer and carried with five aye votes and one nay vote from Mr. Ortman.

A motion was made by Mr. Roberts to approve the amended Economic Development Agreement for the Wildcat Wind Farm LLC. The motion was seconded by Mr. Ellison and carried.
