#### **Selection of Officers**

# A RESOLUTION OF THE RANDOLPH COUNTY BOARD OF COMMISSIONERS ADOPTING THE RANDOLPH COUNTY MULTI-HAZARD MITIGATION PLAN (MHMP)

WHEREAS, the Multi-Hazard Mitigation Planning Committee prepared the Randolph County Multi-Hazard Mitigation Plan (MHMP), a copy of which is incorporated herein by reference. The committee included representatives from Randolph County, the Town of Farmland, the Town of Losantville, the Town of Lynn, the Town of Parker City, the City of Winchester, and the City of Union City. Additionally, the Randolph Central School Corporation, the Union School Corporation, and the Monroe Central School Corporation had representatives on the planning committee; and

WHEREAS, the Multi-Hazard Mitigation Plan (MHMP) recommends many activities that will protect the people and property of Randolph County, which are affected by natural hazards; and

WHEREAS, Randolph County voluntarily participates in the National Flood Insurance Program.

#### NOW, THEREFORE, be it resolved that:

- 1. Adopting the Multi-Hazard Mitigation Plan (MHMP) does not obligate the County to use local tax money for projects identified in any Multi-Hazard Mitigation Plan (MHMP).
- 2. The Multi-Hazard Mitigation Plan (MHMP) for Randolph County, Indiana, is hereby adopted as the county's official plan.
- 3. This resolution shall be in full force and effect from and after its adoption by this board and shall repeal and replace all previous Multi-Hazard Mitigation Plans (MHMP).

Tom made a motion to approve Resolution 2025-01. Missy seconded the motion. All aye votes. Motion carried.

Gary said Mike has sent us all, previous commissioner, Mike Wickersham, that he would like to continue if we would choose to be the liaison for this trail project as it goes through. I think it's a good idea.

Tom said I do too.

Gary said someone like to make a motion to accept Mike and ask him to go liaison for this trail?

Tom made a motion to approve. Missy seconded the motion. All aye votes. Motion carried.

#### Thor Construction Claim \$85,388.37

Gary said okay we have a claim for Thor Construction, number 4, for \$85,388.37. Have you two had the opportunity to look at the claim?

Missy said I did.

Gary said okay. Would somebody like to make a motion to approve this claim? I have looked at it and studied it and it's on track exactly where we're at.

Gary said on the facility, it's not completely done. They tried, everybody tried, but Brad has got permission from the Farmland fire department to remain there 24 hours a day instead of 16. So, he is entering into around the clock service there now. And I don't know, I'll have to talk to Danny to see when the new time to get it done is. It's not long. Any questions on this?

#### County Attorney compensation agreement

Gary said next, we have a contract for the county attorney. Everybody had time to take a look at this? If there're no questions, somebody want to make a motion to enter into this contract with our attorney for next year?

Tom made a motion. Missy seconded the motion. All aye votes. Motion carried.

#### Set EDIT Meeting - Union City Plan

#### Town of Albany request

Gary said we need to set an EDIT meeting for the Union City Plan. Before we set this meeting for Union City Plan, Meeks has sent out to us a request from Albany. Anybody want to entertain that request? I can tell you, I do not at this time.

Missy said I don't.

Gary said okay.

Missy said I would offer to them a few ideas on, Patronicity, for one, Union City raise \$50,000.00 doing that. I think it's within Delaware County's, I know we're a part of it, but.

Gary said barely, we're at Albany Heights, but Randolph County Commissioners contributed a significant amount of money to that splash pad two years. I don't remember the amount, but it was a significant amount.

Meeks said I'll let them know. And if they want to come and get on the agenda and present, that's fine. But, I'll let them, I pretty much let them know that when I sent the email on to you guys.

Gary said did you let them know we appreciate what they did and we did contribute to the splash pad?

Meeks said yep, uh huh.

Gary said thank you. They need to come with a presentation for us anyway. Union City EDIT plan, generally, we've been setting EDIT board meetings at 6:00 o'clock on a Wednesday. So, with that, does anybody have any recommendation on setting the EDIT Plan?

Tom said I will be out of town the following Wednesday, so the 22<sup>nd.</sup>

Gary said you'll be out the 22<sup>nd</sup>?

Tom said no, I'll be back.

Gary said the 22<sup>nd</sup> works for me.

Missy said 22<sup>nd</sup> works for me.

Gary said 22<sup>nd</sup> work for you, Meeks?

Meeks said yes.

Gary said okay. Somebody like to make a motion for 6:00 o'clock on the 22<sup>nd</sup> for the EDIT meeting?

Missy made a motion to approve. Tom seconded the motion. All aye votes. Motion carried.

#### Winchester Farmers Market request

Gary said Winchester Farmers Market request. This is their yearly request we've been doing. Everybody had time to review the request?

Missy said my only question on it is when they're talking about putting livestock onto the west side I mean I think they need to understand that they'd pick up any waste, and I'm sure they would.

Gary said I think it's a good point. I think we could approve this and say if you do a petting zoo, we need to see what you're going to do, come and visit us. Can we do that, Meeks?

Meeks said absolutely.

Gary said somebody like to make a motion to that effect? Except for petting zoo. We're not opposed. We just need some questions answered.

Missy made a motion to approve. Tom seconded the motion. All aye votes. Motion carried.

#### 2025 Commissioner's appointments

Gary said okay. 2025 commissioner appointments. The best way to do it is go through the list. Okay, so the airport board is Tyler Martin, Conan Wallace, Greg Sickels, Jim Michael and Owen Griffith.

Tom said Owen comes off.

Gary said if Owen comes off, do we have a replacement? I believe Owen would be a democrat seat on there, so it would have to be democrat replacement.

Laura said have you talked to Owen whether he wants off or is it just because that's when his terms ends?

Tom said I haven't.

Laura said because you might talk to him.

Tom said he probably would continue.

Gary said do you know Owen?

Tom said I do.

Gary said would you like to call him?

Tom said I will.

Gary said airport manager is Eric Livingston. I think we will vote, Meeks, how should we do that?

Meeks said you can do it all at once or you can.

Gary said let's do it all at once. That's what I, there's one on here we've got to change, I assume. We've got Mike Haffner on here for highway superintendent.

Meeks said yeah, well, you'll just change that.

Gary said alright. Eric Livingston, airport manager, alcohol beverage commission, Paul Faddis. Area Planning board, we'll switch to Tom Kerns or Missy. I guess Missy, in fairness, when Tom and I were talking with APC, he said he would like to remain on the APC board. He's been on there a long time.

Missy said that's great.

Tom said I'll stay on that.

Gary said you'll stay on that one Tom? The citizen for the commissioners is Don Calhoun. I believe he's fine. Area Planning director, Debra Johnting. Building Maintenance Supervisor, Jake Donham. Building Commissioner, Randy Abel. Have you heard of his return to work date?

Laura said he came back today temporarily to see how he could do.

Gary said BZA board citizen members, Drew Cleveland and Jon Peacock, looks good. Community Corrections board, Mike Wickersham needs to come off.

Tom said Drew Cleveland's term is up.

Gary said oh, I see the terms down here now.

Laura said so, normally, like somebody would contact them and the commissioners and see if they want to stay on or not, just like Owen and, Mike used to do it. I don't know how you guys want to do it though.

Gary said I'll reach out to see if Drew will stay. Community Corrections, Mike Wickersham come off, Tom or Missy, would one of you two like to take that?

Missy said I can do that one. Does Mike not want to remain?

Gary said I believe it's a commissioner appointment.

Missy said okay.

Gary said am I right, Meeks?

Meeks said you can appoint anybody you want.

Gary said well I haven't spoke to Mike, but I think it's a commissioner appointment.

Meeks said yeah. It's a good idea to have commissioners on there so you guys know what's going on.

Gary said right. Community committee is president of the commission, council, IT personnel, auditor and the treasurer, county attorney is Meeks Cockerill. Economic Development board, Mike Wickersham, has to come off. Alright. Missy, are you interested in that?

Missy said no.

Gary said and Tom's not, I'll take it. Eastern Indiana Regional Planning Commission, would either of you two be interested in that?

Laura said did you guys see the email I sent on that?

Gary said yes.

Laura said okay, because, I had a long conversation with them and Mike attended. They just need somebody that will attend. It's four meetings a year. It's during lunch.

Gary said I know I can't do that.

Laura said I know.

Tom said that would be tough. Missy, can you do that?

Missy said I can do that.

Gary said that's why I got off of it years ago. I did ask them if they could move it until evening and they said no. I understand. Emergency management, 911 director, Chris Shaneyfelt. Emergency management advisory board, Gary Girton. So, he'll be coming off.

Tom said I can do that.

Gary said Emergency management district 6 planning council, Jennifer Hendrickson. Emergency management direct planning oversite committee, Gary Girton. Tom that goes along with the advisory board.

Tom said yes.

Gary said Emergency management EMS director, Duane Petry come off, Brad Mullen in his place. 4-H Incorporated, I've been on there. I haven't done them much justice. I think I've been to two meetings. Would somebody like to do 4-H?

Missy said I'd do that one.

Gary said okay. Grievance complaint, president of the commissioners. Health Department, Dr. Sowinski. Health Department board, and we have two coming off, right?

Laura said yeah, so those two need to be contacted.

Gary said okay. We have the Health department here. Your board members, do you know the status on them?

Sherri Thompson said I believe that Kathy is going to continue, and I'm not sure what the other one is.

Gary said Jim Tharp, do you know, you don't know about that?

Sherri said he probably will continue, but I haven't talked to him.

Gary said can you reach out and then let the commissioners know?

Sherri said absolutely.

Gary said okay. Thank you. Phil Howell, Joe Edmonds, Samantha Morris and Mindy Winningham and Kelly Campbell. Okay, Mike Haffner come off. Add Jay Long. Jessica Olson will come off as the administrator. Jaycie what's her last name?

Laura said Bergman.

Gary said the Insurance committee, Gary Girton was on.

Laura said so, this is just a as-needed like during when we're renewing, we need somebody to come to the meetings.

Gary said these are kind of middle of the day stuff too.

Laura said we usually try to do them in the mornings, yeah, at 9:00 o'clock.

Missy said Gary, would you have an interest in that?

Gary said huh?

Missy said would you have an interest in that?

Gary said well, not really because I will be working out of town. Would somebody else like to consider it?

Missy said I could do that if you can't. Tom, can you?

Tom said I wouldn't, in meetings in the day, I struggle with also.

Gary said Internal controls oversite, president of the commissioner and council, auditor, clerk and treasurer, is fine. And then, change the names. So, it was Mike Wickersham, Dave

Lenkensdofer, Todd Holaday, Laura Martin, Mindy Peed, Brenda Tharp. L & M Regional Water board, Jessup needs to be contacted. Do you know her, Laura?

Laura said I do not.

Gary said could you give me a phone number?

Laura said I don't know if I have hers, but we could call, and I can call her, Carol.

Gary said could you call Carol?

Laura said uh huh.

Gary said okay. Local Emergency Planning committee.

Tom said I can do that.

Gary said yeah, personal committee, Randolph County dispatch.

Laura said so all three of those?

Gary said yeah. RC Redevelopment commission, annual.

Laura said as far as I know, those three are good to stay on.

Gary said okay, the Randolph County development commission, annual Brody Tarter, Rolland Abraham, Jentry Flesher. What exactly is that? I'm not sure.

Laura said Cardinal Ethanol is a TIF for the county and we need for them to do just as necessary, usually two or three times a year.

Meeks said and there is something coming up on that.

Laura said yeah, and I think they all three will probably stay on.

Gary said Region 6 Executive Council (Work One), Mike Wickersham is on that. That's another day meeting. Missy, are you up for that?

Missy said yeah, I can do that. Before you turn the page, just, I want to clarify the reason I don't want to be on the EDC board is because they have meetings on Tuesday evenings and all through the summer I play golf in a league, and I'm not going to give it up.

Gary said fair enough. Solid Waste, all three commissioners, and Dave Lenkensdofer is on the council still, right Dave?

David Lenkensdofer said as far as I know.

Gary said we'll find out tomorrow, right?

David Lenkensdofer said tomorrow will be the.

Gary said you'll be there today?

David Lenkensdofer said yes, I will.

Gary said Tourism board, Jeanette Sickels, Jim Nunez. Jeanette Sickels went out in 23.

Laura said that's well no, that's why I kind of highlighted those last year because I never did get an update to know if these people are still on there or not. Gary said okay. Liaison for the jail was Gary Girton.

Tom said I'll do that one.

Gary said liaison for the Health Department was Mike Wickersham. Are you good with that one, Missy?

Missy said I can do that.

Gary said liaison for the highway department and EMS is myself. Liaison for the court house and Community Corrections building was Mike Wickersham.
