

ORDINANCE NO. 2008-110

AN ORDINANCE OF THE SHELBY COUNTY COUNCIL,  
SHELBY COUNTY, AMENDING ORDINANCE NO. 1992-4 WHICH  
WAS TITLED "ENHANCED EMERGENCY TELEPHONE SYSTEM (911) FEE

WHEREAS, the Indiana Code, I.C. 36-8-16, authorizes the County fiscal body, to-wit: the Shelby County Council, to adopt an ordinance to establish a telephone system that utilizes the three digit "911" to send automatic number identification and automatic location identification for reporting various emergency situations; and

WHEREAS, Shelby County, Indiana, acting by and through the Shelby County Council did in fact on October 13, 1992 enact an ordinance establishing the enhanced emergency telephone system pursuant to and under the authority of 36-8-16; and

WHEREAS, Shelby County, Indiana now desires to amend the aforementioned ordinance to provide for an increase in the monthly fee established under section five (5) of said aforementioned ordinance; and

WHEREAS, the Shelby County Council desires to ratify, affirm and continue in full force and effect Ordinance 1992-4 enacted by them on October 13, 1992, except for the one aforementioned amendment under section five (5).

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE COUNTY OF SHELBY, as follows:

Section 1. Section five (5) of Ordinance 1992-4 is now hereby amended by amending the first sentence of said section to read as follows: There is hereby imposed on all service users in Shelby County, Indiana, a uniform monthly fee of Two Dollars and five cents (\$2.05).

Section 2. In all other respects Ordinance 1992-4 is hereby ratified, confirmed and approved and continued in full force and effect. This Ordinance is intended to amend the first sentence of section five (5) of Ordinance 1992-4 as set forth in section one (1) of this Ordinance.

Section 3. This Ordinance, the ordinance amending Ordinance 1992-4, shall be in


full force and effect on the first day of the second month after its passage by the Shelby County Council as provided by Indiana statutory authority I.C. 36-8-16-9.

PASSED AND ADOPTED BY THE SHELBY COUNTY COUNCIL this 15<sup>th</sup> day of July, 2008, by a vote of 5 Ayes and 2 Nays.






