## ORDINANCE NO. 2013- /9

AN ORDINANCE to amend the Shelby County Records to vacate a portion of County Road 900 South between County Road 250 West and County Road 375 West in Flat Rock, Indiana.

BE IT ORDAINED by the Board of Commissioners of Shelby County, Indiana, as follows:

<u>Section 1: Purpose.</u> The purpose of this Ordinance shall be to vacate a dedicated public way, being a portion of County Road 900 South between County Road 250 West and County Road 375 West, Flat Rock, IN 47234.

Section 2: Notice Pursuant to IC §36-7-3-10 and IC §36-7-3-12, by certified mail to each owner of land that abuts the property proposed to be vacated was given according IC 5-3-1. Legal notice was published and a public hearing was held on July 1, 2013 at 8:00 P.M. according to law before the Shelby County Commissioners.

<u>Section 3: Vacation of Land</u>. The land for dedicated public ways and the owner of said strips of land subject to said rights-of-way for public way is hereby vacated.

<u>Section 4: Effective Date.</u> This Ordinance shall be in full force and effect from and after its adoption by the Board of Commissioners of Shelby County, Indiana.

<u>Section 5: Repealable Provisions.</u> All ordinances and parts thereof in conflict with the specific amendments or provisions herein provided are hereby repealed.

## <u>VERIFIED PETITION TO VACATE</u> <u>A PORTION OF COUNTY ROAD 900 SOUTH</u>

Comes now the Petitioner, Timothy Emerick, as fee simple owner, and hereby petitions the Board of Commissioners of Shelby County, Indiana, pursuant to IC § 36-7-3-12 and IC § 36-7-3-10, as follows:

## I. Petition To Vacate a Portion of County Road 900 South:

- 2. That a true copy of the aerial map for the area including the right of way in question as provided by the Office of Auditor of Shelby County, Indiana, is attached hereto, made a part hereof, and referred to as Exhibit A.
- 3. That the address of the Petitioner is 1903 West 900 South, Flat Rock, Indiana, being one of the persons owning land abutting a portion of 900 South being vacated between County Road 250 West and County Road 375 West, Flat Rock, Indiana. The other abutting landowners are Aaron Winterroad, 5021 14th Avenue N, St. Petersburg, FL 33710; Thomas Winterroad, 250 W. McKay Road, Shelbyville, IN 46176; Chester Bolls, 3825 W 900 S, Edinburgh, IN 46124; Dennis Cochran, 3339 W 850 S, Shelbyville, IN 46176; and Hamilton Farms, LLC, 3334 W SR 252, Flat Rock, IN 47234.

4. To the best of his knowledge and belief of the Petitioner, the County has not maintained, improved or in any way exercised any control over the portion of County Road 900 South between County Road 250 West and County Road 375 West for at least the last ten (10) years.

5. Petitioner, to the best of his knowledge and belief, states that the County Auditor's Plat does not show that the portion of County Road 900 South that lies between County Road 250 West and County Road 375 West, Flat Rock, Indiana as vacated, or that any adjacent landowner's deeds show any claim to that portion of County Road 900 South.

WHEREFORE, Petitioner request, pursuant to IC § 36-7-3-12, that the Board of Commissioners adopt an ordinance vacating the above described portion of County Road 900 South between County Road 250 West and County Road 375 West, Flat Rock, County of Shelby, Indiana and for all other proper relief in the premises.
