RESOLUTION AUTHORIZING APPLICATION SUBMISSION
AND LOCAL MATCH COMMITMENT

RESOLUTION TO THE BOARD OF COUNTY COMMISSIONERS OF
SHELBY COUNTY, INDIANA, AUTHORIZING THE SUBMITTAL OF THE CFF APPLICATION
TO THE INDIANA DEPARTMENT OF COMMERCE AND ADDRESSING RELATED MATTERS

WHEREAS, the Board of County Commissioners of Shelby County, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its jurisdictional limits; and

WHEREAS, the Housing and Community Development Act of 1974, as amended, authorizes the Indiana Department of Commerce to provide grants to local units of government to meet the housing and community development needs of low and moderate income persons; and

WHEREAS, the Board of County Commissioners of Shelby County, Indiana, has conducted or will conduct public hearings with representatives of the Waldron Conservancy District prior to the submission of an application to the Indiana Department of Commerce, said public hearings to assess the housing, public facilities and economic needs of its low and moderate income residents;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Shelby County, Indiana that:

1. The President is authorized to request and to work with the Board of Directors of the Waldron Conservancy District, Waldron, Indiana to prepare and to submit an application for planning grant funds to address the water distribution system, including the location of a new water well, air stripping or a new filtering system for the existing pumps, the determination of need for either an additional water tower or the expansion of the existing tower, and other engineering and surveying items, and that the Waldron Conservancy District is to execute and to administer a resultant grant including requisite general administration and project management, contracts and agreements pursuant to regulations of the Indiana Department of Commerce and the United States Department of Housing and Urban Development.

2. The Board of County Commissioners of Shelby County, Indiana hereby commits the requisite local funds committed by the Waldron Conservancy District, Waldron, Indiana in the amount of four thousand seven hundred and fifty dollars, (\$ 4,750.00), in the form of Utility Funds, as matching funds for said program, such commitment to be contingent upon receipt of CFF funding from the Indiana Department of Commerce.
