This is a fee of \$50.00 when initiated by a citizen and \$200.00 when rezoning to Industrial, payable to the Spencer County Advisory Plan Commission.
- 2. The applicant shall furnish the Spencer County Advisory Plan Commission a list of adjoining property owners along with their last known addresses.
- 3. A plot drawn to scale, if possible, and submitted in duplicate showing lot and parcel lines, existing structures, proposed locations of other structures, right-of-way lines of streets and alleys and other pertinent right-of-ways, and indicating there on the use applied for in this application.
- 4. Plans for proposed structures, including floor plans and elevations.
- 5. If the applicant is not the owner of the affected property, the owner's notarized written permission must be submitted to the Spencer County Advisory Plan Commission.
- 6. Completed Rezoning Petitions turned in to the Spencer County Advisory Plan Commission by noon on the 1st Wednesday of the Month will be heard the 4th Thursday of the same month.
