# Commissioners Reorganizational Meeting January 3, 2017

Meeting was called to order by Auditor Winkler at 9:20 A.M.

#### President

First order of business was nominations for President. Brown made a motion to nominate Jim Seiler for President. Logsdon seconded the motion. There were no other nominations, motion was approved. The meeting was turned over to President Seiler.

#### Vice-President

Seiler made a motion to appoint Tom Brown as Vice-President. Logsdon seconded the motion. There were no other nominations, motion approved.

#### Attorney

Logsdon made a motion to appoint Jeff Lindsey as Attorney. Brown seconded the motion. There were no other nominations, motion was approved.

### **Meeting Dates & Times**

After discussion it was decided to change the meeting time for 2017. Logsdon made a motion to hold the 2017 commissioner meetings on the first and third Tuesdays at 2:00 p.m. Brown seconded the motion, motion was approved.

### **Roberts Rule of Order Modified**

Logsdon made a motion to approve Roberts Rule of Order Modified retroactive to the beginning of the meeting. Brown seconded the motion, motion was approved.

### **Hwy Report**

Kenney reported that INDOT sent us an unofficial detour for commissioner approval. They will be doing work on SR 66 from Rockport city limits to SR 70 and request the use of old SR 245 as the detour. Logsdon made a motion to approve INDOT's request. Brown seconded the motion, motion was approved. Kenney reported they have the durapatcher out working on some roads in St. Meinrad and have been working on getting roads ready for this year.

Kenney and Chapman have been looking at the union agreement and mentioned that the highway guys will receive the Election Day holidays again this year that other employees do not. Lindsey stated that we don't have much bargaining tools when they are still receiving a pay raise, due to the approval of the salary ordinance. We can ask the council to amend the ordinance to take back the raise until a union agreement is met, but there is a provision in the union agreement that states if a new agreement is not approved the current one stays in effect. Lindsey suggested this be discussed in the upcoming Executive Session. An Executive Session was scheduled for Tuesday, January 17<sup>th</sup> at 1:00 p.m.

## **Legal Report**

Lindsey mentioned that we discussed cancelling Windstream at the beginning of the year. He will check with the judge to ensure everything is ok and will then send a letter to Windstream to cancel. A meeting with the judge is scheduled for January 10<sup>th</sup> at 12:00 p.m. in the Jury Room to discuss possible plans for the third floor.

Lindsey stated that we previously discussed having Kent Irwin go thru and revise our Personnel Policy and possibly come do some training with the employees about policy changes. Brown stated that he read through our personnel policy and had many questions and with the laws and regulations changing all the time he is in favor of pursing that. Lindsey stated that Irwin mentioned \$5,000.00-\$7,500.00 for this work. Auditor Winkler will look to see if we have funds available to pay that and if not we will need to request an additional appropriation. We will discuss again at the next meeting.

#### **Old Business**

## Laptops

Auditor Winkler informed the board in a previous meeting that 4 laptop computers had been given to the county for the commissioner's to use. Logsdon spoke with Heath Therber from Affinity and asked him if he would be willing to train the board on how to use the laptops properly to get the process started. Therber stated he would be happy to provide training and the cost would be \$65.00/hr as a group or per individual. All were in favor of moving forward with setting up training with Therber. Auditor Winkler will contact Therber about training and have him look at the laptops to see if any software is needed.

## **New Business**

Attorney Lindsey presented his contract for commissioner approval. Logsdon made a motion to approve the contract with Attorney Lindsey. Brown seconded the motion, motion was approved.

Brown asked Auditor Winkler to make sure a name plate is ordered for him.

Sheriff McDurmon mentioned that his contract also needs approval. Logsdon made a motion to renew the same contract as previous years. Brown seconded the motion, motion was approved.

Logsdon made a motion to adjourn. Brown seconded the motion, motion was approved. Meeting was adjourned at 10:22 A.M.
