Commissioners Meeting February 4th, 2020

Meeting was called to order by President Jim Seiler at 2:00 P.M.

Minutes

No minutes presented.

Claims

Logsdon made a motion to approve Batch #'s 4288, 4287, 4282, 4285, 4289, 4291 and 4290 as presented. Brown seconded the motion, motion was approved.

VSO Report

Meredith reports he has met with veterans at Willowdale Village in Dale and Millers Merry Manor in Rockport. He states that he met with Kevin Hinton, SW District Service Officer, to discuss upcoming training. Meredith states he was at the Lincoln Public Library in Dale to meet with any veterans that had questions. He also states he attended the annual meeting for the LEDC.

HWY Report

Kenney states they have currently been working with Laura Slusher, state engineer, on intersections and road signs. In the near future they will start placing the new signs. Logsdon states he has been contacted by county citizens about the stop sign at 600E. Citizens have requested that the stop sign be removed from 600E and old 245 intersection. Kenney states he will look at this and see what can be done. Kenny states the 4' pipe has been installed in the REO area close to the high school. Kenney states he believes that INDOT will do a great job on the intersection improvement. Kenney stated crews have been working on 1100N and 600E grading and leveling roads. Brown states on 200 a no truck sign had been placed. Brown states this is agricultural and the farmers need to travel this road. Kenney states at one time trucks were going into a yard at 200. He states that previously trucks had been asked to use 1325. The drivers said the corner at 1325 was too narrow to turn. Lindsey stated that we cannot prevent a farmer from using that road. Logsdon requests Kenney to provide pictures of the intersection at the next Commissioners meeting. Kenney is in agreement.

Indiana Workforce Board

Linda Jones, with the Indiana Workforce Board, is here today to request a Commissioner be placed on the workforce board. This is a two year appointment. Logsdon has previously served on the board. Brown made a motion to appoint Al Logsdon to the Indiana Workforce Board. Seiler seconded the motion, motion approved.

New Business

Affinity Contract

Auditor Greene asked the Commissioners to sign a yearly contract with Affinity. Contract is from February 15th, 2020 to February 15th, 2021 in the amount of \$45,000.00 for IT services. Logsdon made a motion to accept the contract as presented. Brown seconded the motion, motion approved.

Lincoln Heritage Public Library

Ken Schaaf mailed to the Auditors office, a Conflict of Interest Disclosure to be reviewed and approved by the County Commissioners. Logsdon made a motion to approve the Conflict of Interest for Mr. Ken Schaaf. Brown seconded the motion, motion approved.

A letter of request was received from the Lincoln Heritage Public Library requesting Steve Rexing be appointed to the library board, due to Ken Schaaf retiring. The request of appointment would be from March 1st, 2020 to April 30th, 2023. Logsdon made a motion to appoint Steve Rexing, to

the Lincoln Public Library Board, replacing Кел Schaaf as he retires. Brown seconded the motion, motion approved.

Logsdon on behalf of the Commissioners wanted to thank Mr. Ken Schaaf for his many years of service on the Library Board and his many years of serving the community.

2nd Amendment

Representation for the 2^{nd} Amendment presented 448 signatures in favor of Spencer County Indiana being a sanctuary county. They are requesting a review of a map showing the counties that are sanctuary counties. Brown made a motion to have Attorney Lindsey prepare a Resolution stating that Spencer County supports the 2^{nd} Amendment. Logsdon seconded the motion, motion approved.
