Claims

Health Department-COVID-19/Kim Hay

Hay reports the county currently has 132 positive COVID case, 3 deaths and 20 in quarantine. Hay states that social distancing, masks and washing of hands should continue to be followed. Hay states that a vaccine is on the horizon and remains hopeful that these efforts will be successful in the near future. Hay states she will continue to keep everyone up to date on COVID-19.

Cares Act

Dr. Tretter states for the Health Department to effectively and efficiently deliver and administer vaccines throughout the county to reach our residents, they are requesting consideration for the purchase of a van. This van could and would be used as a mobile vaccination unit. Tretter states the cost would be approximately \$70,000.00 and would be reimbursed with the Cares Act. Donna Burroughs with the Town of Grandview comes today to request the taxes that remain on three parcels the town purchased last year be removed. The town has since sold the parcels and it is not the current owners responsibility. Attorney Lindsey states he will address this situation and have an answer and solution at the next meeting.

Census 2020

Al Logsdon reports that Spencer County is doing very well reporting in the 2020 Census. Logsdon encourages Spencer County citizens to reach out to neighbors and friends and remind them to

complete the Census. Logsdon states Spencer County is at a 70% return rate. Logsdon states in approximately two weeks walkers will start the door to door campaign for completing the Census.

Legal Report
