## Commissioners Meeting June 18<sup>th</sup>, 2019

Meeting was called to order by President Jim Seiler at 2:00 P.M.

### **Minutes**

Logsdon made a motion to approve the Commissioners minutes and SWMD minutes from June  $4^{\rm th}$ , 2019 as presented. Brown seconded the motion, motion was approved.

#### Claims

Logsdon made a motion to approve Batch #4085 as presented. Brown seconded the motion, motion was approved.

## **Kovert-Hawkins Architecs**

Hal Kovert presented the findings for the Storm/Sanitary Water Separation. He states the solution they have developed involves the separation of piping in the building attic. This involves removing a section of pipe from the existing roof drains as a vent for the sanitary plumbing system. New vents will be installed and connected to the existing pipes. The roof drains will be piped across the attic and through the exterior wall. Once through the wall the pipe will dump into a scupper (large metal box) that is connected to a downspout. A new downspout will be installed to the ground where it will empty in the catch basin on the west side catch basin and on the east side of the courthouse. Upon approval from the commissioners the county would need to bid out the project. The estimated cost would be \$109,000.00. Brown made a motion to proceed forward with Kovert-Hawkins proceeding with the bid process. Logsdon seconded the motion, motion was approved.
