## Radius/Jeff Quyle

Jeff Quyle with Radius Indiana, Economic Development in Southern Indiana, came with a presentation form Ball State University. Quyle states this study shows the over all tax revenue in 2020 will be down 3.8% to 10.9% below 2019. It assumes over all Indiana tax revenue in 2021 will be down 3.7% to 9.45 below 2019. Quyle states full recovery is not expected before 2022. Quyle also gave 2020 and 2021 revenue reduction projections.

# Republic Transmission/Shawn Mock

Mock comes today to request the Commissioners sign a Mutual Settlement Agreement and Release. This agreement states there is approximately \$36,500.00 on road damages from Republic Transmission. The amount paid by Republic Transmission is increased to Spencer County in the amount of \$67,001.00. Upon the county receiving this amount the Commissioners will execute the Mutual Settlement Agreement. Upon said execution the Commissioners will release the bond in its entirety to Republic Transmission. Mock states this agreement constitutes the entire agreement between parties.

Brown made a motion to accept the request from the Sheriff. Logsdon seconded the motion, motion approved.
