Marksberry

Marksberry contacted Winkler on June 24th and stated the yard had been mowed. Winkler acknowledged the mowing of the yard but stated there are still violations remaining. Marksberry told Winkler his weedeater was broke and the truck was not abandoned. Winkler told Marksberry if the truck was not registered it was in violation. Winkler states there have been no further improvements to the property. Brown made a motion to sign the Finding of Facts, impose the \$100.00 fine and give until August 4th for clean up on this case. Winkler states six property cases have been closed and two properties that have been abandoned are being foreclosed on.

Minutes

Logsdon made a motion to approve the minutes from May 19th, 2020 as presented. Brown seconded the motion, motion was approved.

Claims

Logsdon made a motion to approve Batch #4404, 4403, 4402, 4399 and 4396 as presented. Brown seconded the motion, motion was approved.

Health Department-COVID-19/Kim Hay

Hay reports the county currently has 47 positive COVID cases. Hay states both North and South Spencer schools have plans to set in motion for graduation. Hay states the Oxygen system for the jail is highly recommended by Dr. Tretter, but the not for the courthouse as there is not duct work. Hay states Dr. Tretter recommends the courthouse continue under the same ordinance as previously ordered.

Veteran Service Officer - Butch Meredith

Meredith gave an update of services rendered since the last meeting. Meredith states that he has been trying to update all the local cemeteries in the county. Meredith states that there is a cemetery located across from the old Larkin Baptist Church. This cemetery is on the Howell property and they request they be allowed to maintain the property. Meredith states he will contact the trustee for this property and request approval of maintenance from this family.

Sheriff/Kelli Reinke

Reinke presents the plans for replacing the camera system and vent cleaning. Reinke states there are many things that need to be replaced and or fixed at the jail. Logsdon made a motion for the

sheriff to consult with RQAW not to exceed \$8,000.00 in consulting fees. Brown seconded the motion, motion approved.

Legal Report

Attorney Lindsey states the election office has been given a program named FireEye which is provided by the state. The election board is requesting the Commissioners to execute a Non-Disclosure Agreement, which is required by the state. Attorney Lindsey presents the Non-Disclosure Agreement for signatures. Brown made a motion to sign the Non-Disclosure Agreement for FireEye. Logsdon seconded the motion, motion approved. Attorney Lindsey states that someone has requested to purchase a lot in Holiday Village which is owned by the County. Attorney Lindsey states there are a few pieces of property which the County owns that the Commissioners might want to try to seil. The Assessor would be able to give an approximate value of each parcel.

New Business

Community Corrections Grant Application

Chase Fisher and Dick Hedrick with Community Corrections presents grant applications for the renewing of grants for 2021. The grants for 2021 are as follows; Spencer County Jail Treatment, Spencer County Community Corrections and Spencer County Drug Court. Brown made a motion to approve the grant applications as presented. Logsdon seconded the motion, motion approved.

Probation Grant/Sylvia Holbrook

Holbrook with Spencer County Probation presents the Spencer County Probation Grant for 2021 for approval from Commissioners. Holbrook states there is a slight increase from last year. Logsdon made a motion to accept the grant as presented. Brown seconded the motion, motion approved.

EMA/Stephanie Melton

Melton is requesting on August 15th, 2020 that the Cary Glover Bridge be closed for the hydroplane races. She states this is still in question if the event will take place due to the COVID-19. Melton states she is requesting this closure if the event would continue as planned. Brown made a motion to close the Cary Glover Bridge

Brown made a motion to adjourn. Logsdon seconded the motion, motion approved. Meeting was adjourned at 3:14 P.M.
