

## WABASH COUNTY COUNCIL

The Wabash County Council met in session on Monday, May 15, 2023 in the Commissioner's meeting room of the Wabash County Courthouse. Chairman Kyle Bowman called the meeting to order at 6:00 P.M. Council members present: Bowman, Matt Dillon, Nick Kopkey, Sam Hann, Philip Dale, Matthew Mize and Gary Ridenour. Bowman opened with a word of prayer and led the Pledge of Allegiance. The proceedings of the meeting were recorded by County Auditor Marcie Shepherd.

Chairman Bowman requested that those present silence their cell phones and stated that all public comments regarding agenda and non-agenda items are permitted and encouraged.

First order of business was a review and approval of the minutes of the April 17, 2023 meeting. Dillon made a motion to approve the minutes as presented. Kopkey seconded the motion; it passed by a 6-0-1 Ridenour.

Terry Burnworth, owners' rep for the Jail project gave an update on the progress of the new jail. In the general overview Burnworth said the project is 90% complete based on billing and he estimates the job to be complete in August, with a September move-in date. Matt Mize questioned Burnworth about the status of fixing the roof and how the issue will be completed and when it will be done. Burnworth said he sent out a letter to RQAW and is addressing the issue this week.

Ryan Baker, Wabash County Sheriff, presented:

1. A request to raise part-time pay for Jail and Kitchen staff. Baker reported he is having a hard time finding personnel at the current \$13.60 rate and would like to raise it to \$18.72. Kopkey made a motion to approve moving the pay rate up to \$18.72 per hour. Dillon seconded the motion; it passed by a 7-0 vote.
2. A staffing analysis for the new jail has been received and he will be needing 7-8 new jail officers: 1 full-time kitchen staff, 1 part-time kitchen staff, and a receptionist. Mize asked if the new staff can be phased in depending on the numbers in the jail. Baker said he will be back at the next council meeting with an additional appropriation request.
3. Baker said he will be back next council meeting with requests to increase pay for the Court Officer and request overtime pay for jail training.
4. Baker reported he will be giving the Drug Task Force \$10,000. Council is in agreement with this.

Brian Swihart, Chief Probation Officer, presented a request to pay a \$2,000 stipend to his grant administrator. This stipend will be paid from his 2023 IOCS Family Recovery Grant. Swihart said when the grant ends, the stipend will also end. Mize made a motion to approve the stipend funded by the 2023 grant. Hann seconded the motion; it passed by a 7-0 vote.

Appointment to the Redevelopment Commission: Auditor Shepherd reported the need to reappoint Roger Cromer and Mark Guenin to the Commission. Dale made a motion to approve the appointments. The motion died from lack of a second. Dillon made a motion to appoint Roger Cromer to the Commission. Hann seconded the motion; it passed by a 5-0-2 (Kopkey, Ridenour) vote.

Next on the agenda were the requests for additional appropriations.

Auditor Shepherd reported the program TrueRoll will help catch homestead fraud. This is a one-year contract; we will see if it pays to renew. Hann made a motion to approve the appropriation. Dillon seconded the motion; it passed by a 7-0 vote.

Auditor Shepherd presented the Stop Arm Violation Enforcement (SAVE) grant for approval. The SAVE grant is a reimbursable grant that runs from April 1 to August 31, 2023. The grant does not have benefits, so they would need to come from the Commissioners budget. Hann made a motion to approve the grant. Mize seconded the motion; it passed by a 6-0-1(Ridenour) vote.

Shepherd notified the council that the Bowen Center was not awarded the grant for which Opioid Fund matching funds had been approved in their February 2023 meeting.

With no other business to come before the Council, Chairman Bowman adjourned the meeting. The next scheduled meeting of the Wabash County Council is June 19, 2023.
