GENERAL ORDINANCE NO. 85- 4, 2008

AN ORDINANCE ESTABLISHING THE WABASH COUNTY SEX OR VIOLENT OFFENDER ADMINISTRATION FUND, AN ANNUAL SEX OR VIOLENT OFFENDER REGISTRATION FEE, AND A SEX OR VIOLENT OFFENDER ADDRESS CHANGE FEE

WHEREAS, the Board of Commissioners of Wabash County, Indiana, is the executive and legislative body for Wabash County.

WHEREAS, subject to the provisions of I.C. 36-2-13-5.6, the Board of Commissioners may adopt an ordinance:

- (1) requiring the Sheriff of Wabash County, Indiana ("Sheriff"), to collect:
 - (A) an annual sex or violent offender registration fee, and
 - (B) a sex or violent offender address change fee; and,
- (2) establishing a county sex and violent offender administration fund to fund the administration of the sex and violent offender registration system.

NOW, THEREFORE, IT IS NOW ORDAINED AS FOLLOWS:

1. Establishment of Fund. There is established the Wabash County Sex and Violent Offender Administration Fund to fund the administration of the sex and violent offender registration system.

2. Registration Fee. A sex or violent offender registering in the sex and violent offender registration system in Wabash County, Indiana, shall pay an annual registration fee of Fifty Dollars (\$50.00).

3. Address Change Fee. A sex or violent offender registered in the sex and violent registration system in Wabash County, Indiana, shall pay an address change fee of Five Dollars (\$5.00) per address change.

4. Collection of Fees. The Sheriff shall collect the Registration Fee upon the initial registration of the offender in the sex and violent offender registration system and annually thereafter so long that offender continues to be registered in the system. The Sheriff shall collect the Address Change Fee each time a sex or violent offender registered in the system registers an address change with the Sheriff.

5. Transfer of Fees. Each month, the Sheriff shall transfer fees collected under this Ordinance to the Wabash County Auditor.

6. Duties of Auditor. The Wabash County Auditor shall monthly:

- 6.1. deposit ninety percent (90%) of any fees collected under this Ordinance in the Wabash County Sex and Violent Offender Administration Fund; and,
- 6.2. transfer ten percent (10%) of any fees collected under this Ordinance to the State of Indiana for deposit in the state sex and violent offender administration fund under I.C. 11-8-8-21.


7. Permitted Appropriations from Fund. The Wabash County Council may appropriate money from the Wabash County Sex and Violent Offender Administration Fund to an agency or organization involved in the administration of the sex and or violent offender registry to defray the expense of administering or ensuring compliance with the laws concerning the Indiana sex and violent offender registry.
