ORDINANCE # 85-7
BEING AN ORDINANCE VACATING A PORTION OF A PUBLIC WAY
IN THE TOWN OF LAKETON, INDIANA

WHEREAS, CLARENCE GRIESE has petitioned the Board of Commissioners of Wabash County, Indiana, to vacate a portion of a public way within the Town of Laketon, Wabash County, Indiana, consisting of a portion of a public way, to-wit:

All that portion of Mill Street located in the Town of Laketon, Wabash County, Indiana, which lies between Lots 2 and 3 and Lots 14 and 15 of the Original Plat of the Town of Laketon, Wabash County, Indiana.

WHEREAS, the Petitioner is the owner of Lots contiguous thereto and is interested therein; and,

WHEREAS, notice of his petition and the public hearing thereon has been provided by publication and by certified mail to all abutting property owners, as required by law.

NOW, THEREFORE, BE IT ORDAINED THAT:

1) That portion of a public way, to-wit:

All that portion of Mill Street located in the Town of Laketon, Wabash County, Indiana, which lies between Lots 2 and 3 and Lots 14 and 15 of the Original Plat of the Town of Laketon, Wabash County, Indiana.

is hereby vacated and the fee thereof shall revert to the adjoining or abutting property owners in accordance with the law.

2) The Auditor shall furnish a copy of this ordinance to the County Recorder for recording and to the County Auditor, as required by Indiana Code 36-7-3-12.

BE IT FURTHER ORDAINED, THAT this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
