## GENERAL ORDINANCE NO. 2002 - II

## COUNTY ROAD SIGN ORDINANCE

BE IT ORDAINED by the Board of Commissioners of Wabash County, Indiana, under the authority of Indiana Code 8-17-1-1 et, seq, and Indiana Code 9-4-1-1 et. seq. and all acts amendatory thereto of the General Assembly of the State of Indiana;

WHEREAS, the Board of Commissioners of Wabash County, Indiana, has determined that there is a need to exclude commercial truck on the roads as described hereinafter and for NO TRUCK traffic signs to be located as shown:

- 1. Slocum Trail for eastbound traffic from State Road 13, placed at SE corner
- 2. Slocum Trail for eastbound traffic from 100W, placed @ SE corner
- 3. Old State Road 13 for northbound traffic (northeast) from State Road 13, placed at SE corner
- 4. Slocum Trail for northbound traffic @ 1200 S, placed at SE corner
- 5. 1200 S for westbound traffic at intersection of Slocum Trail
- 6. 1200 S for westbound traffic @ 100 W, placed NW corner
- 7. 1200 S for eastbound traffic @ 100W, placed SE corner
- 8. 1200 S for eastbound traffic @ State Road 13, placed at SE corner

WHEREAS, it is the responsibility of the County of Wabash for the placement of the signs.

NOW, THEREFORE, from and after the erection of appropriate signs, no commercial truck traffic shall be allowed on the County roads referred to hereinafter:

- 1. Slocum Trail for eastbound traffic from State Road 13, placed at SE corner
- 2. Slocum Trail for eastbound traffic from 100W, placed @ SE corner
- 3. Old State Road 13 for northbound traffic (northeast) from State Road 13, placed at SE corner
- 4. Slocum Trail for northbound traffic @ 1200 S, placed at SE corner
- 5. 1200 S for westbound traffic at intersection of Slocum Trail
- 6. 1200 S for westbound traffic @ 100 W, placed NW corner
- 7. 1200 S for eastbound traffic @ 100W, placed SE corner
- 8. 1200 S for eastbound traffic @ State Road 13, placed at SE corner

The effect of this Ordinance shall be to eliminate any and all commercial truck traffic traveling on the County roads as listed herein.
