**GENERAL ORDINANCE NO. 85-9, 2010**

**AN ORDINANCE VACATING AN ALLEY IN SPEICHERVILLE, INDIANA**

WHEREAS, there was filed a petition to vacate two alleys in Speicherville, Indiana.

WHEREAS, on December 20, 2010, as required by law and following proper mailing and publication of notice, a public hearing was held on said petition.

WHEREAS, on December 20, 2010, it was deemed by the Board of Commissioners of Wabash County, Indiana, to be in the best interests of the County to vacate the alleys as requested.

IT IS NOW ORDAINED THAT THE FOLLOWING DESCRIBED ALLEYS ARE NOW VACATED:


A ten foot wide alley starting at the northeast corner of lot 8, then west along the north lines of lot 8, 7, 6, 5 and 4 to the northeast corner of lot 4, then northeast to the southwest corner of parcel #85-11-19-300-005.000-003, containing 1.89 acres, then east along south property line of the 1.89 acres to the southeast corner of said parcel, then south to the point of beginning.


**ALSO**


A sixteen (16) foot wide alley lying between lots 4 and 5 of the amended plat of the Town of Speicherville.
