GENERAL ORDINANCE NO. 85-10, 2010

AN ORDINANCE VACATING AN ALLEY IN LIBERTY MILLS, INDIANA

A 16.5 foot wide alley and the un-vacated portion of Railroad Street beginning at the northwest corner of lot 33 of Comstocks 2nd Addition, then north along the east right of way of 2nd Street to the south line of a 3.07 acre parcel, 85-03-22-302-098.000-001, then in a northeasterly direction along the south line of the 3.07 acre parcel to the west right of way of 3rd Street, then south parallel with the 3rd Street right-of-way to the northeast corner of lot #27 of Comstocks 2nd Addition in a west and southwesterly direction to the northwest corner of lot #33.
