## ORDINANCE NO. 91- /

### ORDINANCE ESTABLISHING THE COUNTY CORRECTIONS FUND

Whereas, SEA 395, (1986) added I.C. 11-12-6 to the Indiana Code to provide for establishment of a county corrections fund; and

Whereas, I.C. 11-12-6-6 provides that a county legislative body may annually adopt an ordinance to elect to receive deposits from the State Department of Corrections and to establish a county correction fund; and

Whereas the county corrections fund may be used only for funding the operation of the county jail, or jail programs, and

Whereas, the county legislative body may elect to receive deposits at either Level 1, Level 2, or Level 3 funding; and

Whereas, Level 3 is most appropriate level of participation for Wabash County; therefore:

# BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF WABASH COUNTY

#### that:

- Section 1. a county corrections fund is established for Wabash County;
- Section 2. the legislative body elects to receive deposits from the State Department of Corrections to be deposited in the Wabash County Corrections fund; and
- Section 3. said county corrections fund shall only be used for funding the operations of the county jail or jail programs; and money remaining in the county corrections at the end of the year does not revert to any other fund but remains in the county corrections fund.
- Section 4. the county legislative body elects to receive deposits at Level 3 funding from the State Department of Corrections;
- Section 5. this ordinance shall be in full force and effect upon passage.

## ORDINANCE ESTABLISHING THE COUNTY CORRECTIONS FUND

#### and MISDEMEANANT PROGRAM

Whereas, SEA 395, (1986) added I.C. 11-12-6 to the Indiana Code to provide for establishment and funding of a county corrections fund;

Whereas, this ordinance has established a county corrections fund;

Whereas, the legislative body has elected to receive deposits from the State Department of Corrections as Level 3 funding; and

Whereas, the Board of Commissioners of Wabash County has established a county corrections fund by ordinance; and

Whereas, the Board of Commissioners of Wabash County has adopted by ordinance, a county corrections fund wherein receipts deposited shall be for operations of the county jail or jail programs; and

Whereas, I.C. 11-12-6-6 established the county fiscal body as administrator of the county corrections fund; therefore

BE IT ORDAINED BY THE COUNTY COUNCIL OF WABASH COUNTY

#### That:

- Section 1. the Wabash County Council hereby elects to received deposits from the Department of Corrections in accordance with I.C. 11-12-6.
- Section 2. the Wabash County Council hereby elects to receive such deposits at Level 3 funding.
- Section 3. there is hereby created a "County Corrections Fund", to be administrated by the Wabash County Council. The Fund shall consist of deposits received from the Department of Corrections in accordance with I.C. 11-12-6.
- Section 4. the county corrections fund may be used only for funding the operation of the county jail or jail program. Any money remaining in a county corrections fund at the end of the year does not revert to any other fund but remains in the county corrections fund.

Section 5. this ordinance shall be in full force and effect upon passabe.
