

GENERAL ORDINANCE NO. II, 1989

ORDINANCE VACATING ALLEY

WHEREAS, Vanessa Truman submitted her Petition to Vacate Alleys with the Auditor of Wabash County, Indiana, on February 8, 1989, requesting the vacation of an alley 16 feet wide running East and West between Lots 26 and 27 in Foust's Third Addition to the Town of Servia, Indiana, and the vacation of an alley 16.5 feet wide East and West by 280.5 feet North and South located on the West end of Lots 25, 26, 27, and 28 of Foust's Third Addition to the Town of Servia, Wabash County, Indiana; and

WHEREAS, the Board of Commissioners of Wabash County, Indiana, conducted a hearing thereon on the 27th day of February, 1989, at 9:00 a.m. in the Commissioner's Room in the basement of the Courthouse, Wabash, Indiana, and heard evidence thereon; and

WHEREAS, due notice of said hearing was had in the North Manchester News Journal on the 13th day of February, 1989; and

WHEREAS, due notice of said hearing was made upon the adjacent property owner, Manchester College, by certified mail, and received by said adjacent property owner on February 9, 1989; and

WHEREAS, the Board of Commissioners of Wabash County, Indiana, finds that the subject alleys have not been used as alleys for an extensive period of time, in excess of ten (10) years, and are used solely as a driveway and yard area and that improvements have been placed thereon and that no objections have been made to the vacation of same and that it is in the best interest of the petitioners and the County of Wabash, Indiana, that same be granted.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Wabash County, Indiana, that:

The alley, 16.5 feet wide running North and South by 132 feet in length East and West located between Lots 26 and 27 in Foust's Third Addition to the Town of Servia, Wabash County, Indiana, which is located in the Northeast Quarter of Section 21, Township 29 North of Range 7 East, Wabash County, Indiana, should be and hereby is vacated.

NOW, THEREFORE, BE IT FURTHER ORDAINED by the Board of Commissioners of Wabash County, Indiana, that:

The alley, 16.5 feet in width East and West by 280.5 feet in length running North and South, located on the West end of Lots


25, 26, 27 and 28 of Foust's Third Addition to the Town of Servia, Wabash County, Indiana, and located in the Northeast Quarter of Section 21, Township 29 North, Range 7 East, Wabash County, Indiana, should be and hereby is vacated.


The Auditor is hereby ordered to furnish a certified copy of this Ordinance to the County Recorder for recording pursuant to law.


