

AN ORDINANCE FOR THE VACATING OF COUNTY ROADWAY

BE IT ORDAINED by the Board of Commissioners of Wabash County, Indiana, under authority of Indiana Code 8-20-1-1 et seq, and all other acts amendatory thereto of the General Assembly of the State of Indiana;

WHEREAS, the Board of Commissioners of Wabash County, Indiana, has determined that it would be in the best interest of public safety and welfare and for the best interest of all residents of Wabash County that the following described portions of roadway be vacated:

1. Vacation of a Portion of County Road 600 West

Beginning at the Common Corner between the Southeast Corner of Section 13, T29N, R5E, Pleasant Township, Wabash County, Indiana and the Southwest Corner of Section 18, T29N, R6E, Pleasant Township, Wabash County, Indiana; thence North on the Common Section line between said Section 13 and 18 a distance of 1200 feet.

2. Vacation of a Portion of County Road 900 North

Beginning at the Common Corner between the Southeast Corner of Section 13, T29N, R5E, Pleasant Township, Wabash County, Indiana and the Northeast Corner of Section 24, T29N, R5E, Pleasant Township, Wabash County, Indiana; thence West on the Common Section line between said Section 13 and 24 a distance of 2600 feet.

NOW THEREFORE, from and after the completion of all necessary and appropriate processes of notice and hearing thereon that the following portions of county roads as designated hereinafter shall be and are vacated, no longer to be a part of the county highway system, to-wit:

1. Vacation of a Portion of County Road 600 West

Beginning at the Common Corner between the Southeast Corner of Section 13, T29N, R5E, Pleasant Township, Wabash County, Indiana and the Southwest Corner of Section 18, T29N, R6E, Pleasant Township, Wabash County, Indiana; thence North on the Common Section line between said Section 13 and 18 a distance of 1200 feet.

2. Vacation of a Portion of County Road 900 North

Beginning at the Common Corner between the Southeast Corner of Section 13, T29N, R5E, Pleasant Township, Wabash County, Indiana and the Northeast Corner of Section 24, T29N, R5E, Pleasant Township, Wabash County, Indiana; thence West on the Common Section line between said Section 13 and 24 a distance of 2600 feet.
