

GENERAL ORDINANCE # 85-9-A

AN ORDINANCE FOR THE VACATION OF PUBLIC RIGHT-OF-WAY

BE IT ORDAINED by the Board of Commissioners of Wabash County, Indiana, under authority of Indiana Code 8-20-1-1 et seq, and Indiana Code 36-7-3-12, and all other acts amendatory thereto of the General Assembly of the State of Indiana;

WHEREAS, the Board of Commissioners of Wabash County, Indiana, has been presented a duly prepared and delivered petition for vacation of public right-of-way, being an alley located in Speicherville (Spikerville), Indiana, and more specifically described as follows:

A part of the original plat of Spikerville, as amended, found in Plat Book #3, page 43, in the office of the Wabash County Recorder, being an alleyway ten (10) feet in width, running east and west from State Road #13 to Grant Street, between lots numbered 16, 17, 18 & 19, all being a part of Lagro Township, Wabash County, Indiana.

WHEREAS, said petition has been duly advertised and notice delivered and/or waived as required;and,

WHEREAS, hearing on said petition has been held and concluded on the 9<sup>th</sup> day of December, 1985; and

WHEREAS, the Board of Commissioners of Wabash County, Indiana have determined that it would be in the best interest of public safety and welfare, and in the best interests of the residence of Wabash County, Indiana, and more particularly in the bests interests of the land owner directly affected by the alleyway described hereinabove for it to be vacated.

NOW THEREFORE, IT IS HEREBY ORDAINED AND DIRECTED that the certain alleyway located in Speicherville(Spikerville) Wabash County Indiana, & more particularly described as follows, to-wit:

A part of the original plat of Spikerville, as amended, found in Plat Book #3, page 43, in the office of the Wabash County Recorder, being an alleyway ten (10) feet in width, running east and west from State Road #13 to Grant Street, between lots numbered 16,17,18 & 19, all being a part of Lagro Township, Wabash County, Indiana.

be and is hereby vacated, no longer to be a part of the public right-of-way system in Wabash County, Indiana.


