## GENERAL ORDINANCE 84-3

## AN ORDINANCE ESTABLISHING MAXIMUM WEIGHT LIMITATIONS FOR BRIDGES

BE IT ORDAINED by The Board of Commissioners of Wabash County, Indiana, under authority of Indiana Code: 8-17-1-1 et seq, and Indiana Code: 9-4-1-1 et seq, and Indiana Code 17-2-2.5-1 et seq, and all acts amendatory thereto of the General Assembly of the State of Indiana;

WHEREAS, The Board of Commissioners of Wabash County, Indiana has reviewed and examined the maximum safe weight levels on all bridges situated in Wabash County, Indiana, and has determined that the previously set maximum weights established in General Ordinance No. 80-7, dated Oct. 14, 1980 should be abolished and new standards and limitations thereon set,

AND WHEREAS, in so doing The Board of Commissioners of Wabash County are specifically and intentionally revoking General Ordinance No. 80-7,

NOW THEREFORE, from and after the enactment of this ordinance the gross weight of vehicles using bridges situated within Wabash County, Indiana is now limited as follows:
