AN ORDINANCE OF WABASH COUNTY, INDIANA CREATING AN  
ECONOMIC DEVELOPMENT DEPARTMENT TO BE KNOWN AND DESIGNATED  
AS THE WABASH COUNTY ECONOMIC DEVELOPMENT COMMISSION

WHEREAS, the Legislature of the State of Indiana has authorized cities, towns, and counties in Indiana to create departments to be known and designated as Economic Development Commissions, (IC36-7-12-1 thru 36-7-12-38), to serve in the public and governmental capacity in cooperation with private enterprise for the purpose of economic development of Wabash County; and

WHEREAS, the economic development of Wabash County, Indiana is and would be in the best interest of the citizens of Wabash County, Indiana, so that a Wabash County Economic Development Commission should and ought to be established to carry out such programs.

NOW THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF WABASH COUNTY, INDIANA IN MEETING ASSEMBLED THAT:

SECTION I

A new department to be known and designated as the Wabash County Economic Development Commission be, and the same is hereby created and established with power and authority to act as provided by law under IC36-7-12-18, excepting from those delineated powers sub-paragraph number two (2) referring to the exercise of the power of eminent domain, and sub-paragraph number eight (8) referring to the issuance of bonds, notes, or warrants for financing.

SECTION II

The County Commissioners of Wabash County, Indiana, be and hereby are authorized and empowered to create by appointment a Wabash County Economic Development Commission, and, in general to do any and all things necessary for the promotion of the rights, duties, powers and privileges of said Wabash County Economic Development Commission.

SECTION III

This ordinance shall be in full force and effect from and after its passage, due attestation and approval by the Commissioners of Wabash County.
