Except for areas commencing at a spike set at the Southeast corner of said South West quarter, thence West along the South line thereof One Thousand Nine Hundred Eighty-two and Eighteen hundredths (1982.18) feet to an iron stake set at a point six hundred sixty (660) feel East from an iron stake set at the Southwest corner of saidSouthwest quarter; thence North No (0) degrees forty-nine 49) minutes Thirty 30) seconds East parallel with the West line of said Southwest quarter One Thousand (1000) feet to a point for a place of BEGINNING: thence North no (0) degrees Forty-nine (49) minutes thirty (30) seconds East parallel with said west line One thousand Six Hundred Forty-three and Four tenths (1643.4) feet to an iron stake on the northline of said Southwest quarter; thence South Eighty-nine (89) degrees, forty-three (43) minutes Thirty (30) seconds East Nine

Hundred Thirty-two and Eighty-twohundredths (932.82) feel to a

spike set in the centerline of old State Road #15: thence South Eighteen '18' degrees Twenty-one (21) minutes Thirty (30') seconds East along the centerline of old State Road #15 One Thousand Four Hundred Sixty-four and Fifty-five hundredths (1464.55 feet to a spike: thence South Eighty (80') degrees Three (3') minutes Fifteen (15') seconds West One Thousand Four Hundred Thirty-nine and Sixty-five hundredths (1439.65') feet to the place of beginning.
