

GENERAL ORDINANCE NO. 2
1966

AN ORDINANCE CHANGING THE BOUNDARIES
OF THE ELECTION PRECINCTS OF CHESTER
TOWNSHIP IN WABASH COUNTY, INDIANA.

WHEREAS, more than thirty (30) electors of Chester Township of Wabash County, Indiana have heretofore filed with the County Commissioners of Wabash County, Indiana, a petition requesting that the precincts of Chester Township in Wabash County, Indiana be changed so that the voting precincts for the Town of North Manchester, Indiana be consistent with and within the limits of the boundaries of said town as presently fixed, and,

WHEREAS, a hearing on said petition was held on the 20th day of December, 1965 wherein notice was given by publication and all of said petitioners were entitled to be present at the hearing of said petition, and,

WHEREAS, said hearing on said petition was held on the 20th day of December, 1965 and no persons were present to object to the granting of said petition, and,

WHEREAS, the Board of County Commissioners of Wabash County, Indiana have carefully considered said petition and are of the opinion that the same ought to be granted,

NOW, THEREFORE, BE IT ORDAINED AND ORDERED BY THE BOARD OF COUNTY COMMISSIONERS OF WABASH COUNTY, INDIANA, that:

1. The granting of the petition heretofore filed by thirty (30) or more electors who are residents of Chester Township and the County of Wabash, Indiana, will be to the convenience of the public and for the public good.

2. The Board of County Commissioners of Wabash County, Indiana hereby ORDERS that the voting precincts in Wabash County, Indiana be, and they are hereby changed as follows:

(a) The previous precincts for Chester Township in Wabash County, Indiana, being Precincts #1 and #2 of Chester Township, in Wabash County, Indiana, are hereby changed, altered and superseded.

(b) Six new voting precincts in Chester Township in Wabash County, Indiana are hereby created, the same precincts shall be bounded and described as follows:

PRECINCT #1
Chester Township
Wabash County, Indiana

BEGINNING at the southwest corner of the corporate limits of the Town of North Manchester, Indiana, thence East along the south corporate boundary of said town to a point where it intersects with the Shock Road, thence east along the center of the Shock Road to a point where the Shock Road intersects with the Nehr Road, thence south along the center of the Nehr Road to a point where it intersects with the Hanley Road, thence east to the east line of Chester Township, thence south along the east line of Chester Township to the southeast corner of Chester Township, thence west along the south line of Chester Township to the southwest corner of said township, thence north along the west boundary of Chester Township to the place of beginning.

PRECINCT #2
Chester Township
Wabash County, Indiana

BEGINNING at the northeast corner of Chester Township thence south along the east line of said township to the northwest corner of the corporate limits of the Town of North Manchester, Indiana, thence meandering in an easterly direction along the northern corporate limits of said town to the northeast corner of said town, thence meandering in a southerly direction along the eastern corporate limit line of the Town of North Manchester, Indiana, to a point where it intersects with the Shock Road, thence east along the center of the Shock Road to a point where it intersects with the Nehr Road, thence south along the center of the Nehr Road to a point where it intersects with the Hanley, Road, thence east to a point where it intersects with the eastern line of Chester Township, thence north to the northeast corner of Chester Township, thence west along the northern line of Chester Township to the place of beginning.

PRECINCT #3
Chester Township
Wabash County, Indiana

BEGINNING at the point in the west corporate boundary of the town of North Manchester, Chester Township, Wabash County, Indiana, where the centerline of West Main Street extended west would intersect said boundary; thence east along the centerline of West Main Street extended and the centerline of West Main Street and the centerline of State Road #114 to the east boundary of said town; thence south and west along said east boundary and the south boundary of said town as they meander to said west boundary; thence north along said west boundary to the place of beginning.

PRECINCT #4
Chester Township
Wabash County, Indiana

BEGINNING at the point where the centerline of Sycamore Street intersects the centerline of State Road #114, in the town of North Manchester, Chester Township, Wabash County, Indiana; thence north along the centerline of Sycamore Street to Sunset Drive; thence north along the centerline of Sunset Drive to the centerline of Woodland Drive; thence north parallel with Wayne Street to the north corporate boundary of said town; thence east along said north boundary to the east boundary; thence south along said east boundary to the center of State Road #114; thence west along the center of said State Road to the place of beginning.

PRECINCT #5
Chester Township
Wabash County, Indiana

BEGINNING at the point where the centerline of Sycamore Street intersects the centerline of State Road #114, in the town of North Manchester, Chester Township, Wabash County, Indiana; thence north along the centerline of Sycamore Street to Sunset Drive; thence north along the centerline of Sunset Drive to the centerline of Woodland Drive; thence north parallel with Wayne Street to the north corporate boundary of said town; thence west along said north boundary to the point where the west line of Maple Street extended north would intersect; thence south along said west line of Maple Street extended and the west line of Maple Street to the center of said State Road; thence east along the center of said State Road to the place of beginning.

PRECINCT #6
Chester Township
Wabash County, Indiana

BEGINNING at the intersection of the west line of Maple Street and the centerline of State Road #114, in the town of North Manchester, Chester Township, Wabash County, Indiana; thence west along the centerline of said State Road and the centerline of West Main Street and the centerline of West Main Street extended to the west line of the corporate boundary of said town; thence north along said boundary to the south boundary; thence west along said south boundary to the west boundary; thence north along said west boundary to the north boundary; thence southeast and east along said north boundary to the point where the west line of Maple Street extended north would intersect; thence south along said west line extended and the west line of Maple Street to the place of beginning.
